Dear Fellow Mississippians:

I am pleased to present the Mississippi Department of Corrections (MDOC) 2012 Annual Report. This report represents the scope and depth of this agency and its staff during Fiscal Year July 1, 2011 through June 30, 2012. It also provides an in-depth profile of the state's felony population and MDOC's tradition of prudent accountability and excellence in public service to the citizens of Mississippi.

I am proud of our many accomplishments during Fiscal Year 2012, and am pleased to share a summary with you.

- Offenders in the Community Work Centers contributed \$17,772,600 in free labor to local, county, state and non-profit charitable organizations throughout the state during Fiscal Year 2012. Also, offenders in the Joint County-State Work Programs contributed \$13,692,640 in free labor to local, county, state and non-profit charitable organizations during Fiscal Year 2012.
- During Fiscal Year 2012, educational programs offered to inmates resulted in 5,232 inmates successfully completing the following programs: General Education Development (GED) – 651, Vocational Trades – 930 and Alcohol & Drug – 3,651.
- The Mississippi Department of Corrections has reduced the recidivism rate from 30.31% to 27.65% in the last five years. This reduction has created an estimated annual cost avoidance of \$8,562,126 for the agency.
- The Intensive Supervision Program (ISP) or house arrest has resulted in an estimated total cost avoidance of \$64,028,592 from fiscal years 2000-2012.
- Since its inception in 2004 under Section 47-7-4 of state law, the Conditional Medical Release Program has resulted in an estimated total cost avoidance of at least \$6,137,203.
- MDOC has saved over \$19,100,000 from January 2009 through June 2012 as a result of the Division of Medicaid paying for services provided to Medicaid eligible inmates. MDOC reimburses Medicaid at the state match portion of the provider statement.
- MDOC has a self-insured Workers Compensation Program that yields an average cost savings of over \$400,000 each year. The program began on January 1, 2005.
- MDOC has saved approximately \$1,900,000 in field officers' salaries each year by requiring offenders to pay supervision fees via electronic methods. In June 2009, MDOC eliminated field officers' duty of collecting fees from supervised offenders. This duty required 12% of officers' time.

- Since November 2000, MDOC has provided services to victims. The primary function of the Division of Victims Services (DVS) is to register crime victims requesting notification prior to an inmate's release. At the end of June, 5,562 victims were registered with the program. The services include:
 - Offender status
 - Crisis intervention
 - Information regarding the Crime Victim Compensation Program and Crime Victims' Rights
 - Liaison with law enforcement agencies and field officers
 - Restitution matters
 - Protective orders
 - Addressing harassment by offenders
 - Support and assistance during victim/offender dialogue
 - Meetings with the Parole Board
 - Preparation/Escort services during executions
- Mississippi's Statewide Automated Victim Information Notification Service (MS SAVIN) is a vital tool for information providing added safety not only for individual victims, but also to the community as a whole. SAVIN is designed to provide registered victims/survivors real time information on state inmates and offenders housed in participating county jails. Registered users have access to timely information on offenders 24 hours a day by calling an 800 number and by accessing the Vinelinks internet website. At the end of Fiscal Year 2012, 80 counties were participating in SAVIN with an additional county soon to follow, bringing the total to 81 counties. SAVIN also implemented four additional services: CHOICE, Data Bridge, SMS, and Registration Link.

With continued commitment to fiscal responsibility, I look forward to the challenges we face together in the coming year.

It is an honor to serve as your Commissioner.

Commissioner Christopher B. Epps is the longest serving Commissioner of the Mississippi Department of Corrections.

He was first appointed by then Democratic Gov. Ronnie Musgrove on Aug. 30, 2002, and reappointed on Jan. 13, 2004, by then Republican Gov. Haley Barbour, who served two terms.

On Jan. 9, 2012, Republican Gov. Phil Bryant reappointed him.

Commissioner Epps is a nationally recognized leader in Corrections. He is in high demand also as a motivator and has been featured in such nationally recognized publications as *The New York Times* and *Time* magazine.

In January 2013, he was sworn in as President of the American Correctional Association (ACA).

In June 2012, he testified before the United States Senate Judiciary Subcommittee on the Constitution, Civil Rights and Human Rights.

Through his leadership, Mississippi has become a model for corrections reform.

Commissioner Epps started his career with the Department of Corrections in 1982 as a correctional officer at the Mississippi State Penitentiary at Parchman.

He has since served extensively with the agency, holding several positions, including Chief of Staff, Deputy Commissioner of Institutions, Deputy Commissioner of Community Corrections, Director of Offender Services, Deputy Superintendent, Chief of Security, Corrections Case Management Supervisor, Director of Treatment Services, Corrections Case Manager, Disciplinary Hearing Officer/Investigator and Director of Records.

Commissioner Epps has held numerous leadership positions in Corrections and in the military.

Before being elected President of the American Correctional Association (ACA) in May 2010, he had served as Auditor. He also had been elected to the Commission on Accreditation in 2004 and as Treasurer in 2008, a position that placed him on the ACA Executive Committee.

In addition to his leadership with ACA, he is Vice-President of the Association of State Correctional Administrators (ASCA) and was ASCA Treasurer.

Commissioner Epps received an honorable discharge from the Mississippi National Guard in March 2008, when he retired as a lieutenant colonel, having served in the armed forces since 1984.

In addition to the ACA and the ASCA, Commissioner Epps' correctional/civilian affiliations include the North American Association of Wardens and Superintendents (NAAWS), the Southern States Correctional Association (SSCA), the Mississippi Association of Professionals in Corrections (MAPC), and the Correctional Peace Officers Foundation (CPOF).

He is past president of the SSCA and former chairman of the Mississippi Wireless Communications Commission. He serves on the Correctional Peace Officers Foundation National Board of Directors, the Mississippi Prison Industries, the Mississippi Drug Court Advisory Committee, the Mississippi Analysis and Information Center, the Mississippi Broadband Connect Coalition, the Council of Advisors for the College of Public Service at Jackson State University, the State Workforce Investment Board, and the Interstate Commission for Adult Offender Supervision. He formerly served as a member of the Board of Directors of Alcohol Services and as a mentor with Big Brother/Big Sister of Mississippi.

Commissioner Epps' list of accomplishments and awards also are as numerous. In December 2012, he was honored as the nation's Outstanding Corrections Commissioner for 2011 with the Michael Francke Award from the ASCA. Further honors include: Humanitarian of the Year in 2007 by the MAPC, Professional of the Year in 2000 and 2004, the 2007 Distinguished Alumni Award from the National Association for Equal Opportunity in Higher Education, one of the "50 Most Influential African Americans in Mississippi" by BlackMississippi.com, and The Distinguished Public Service Award by the University of Southern Mississippi, Department of Criminal Justice, in 2004. In 2007, then-Kentucky Gov. Ernie Fletcher awarded him the honorary title "Kentucky Colonel."

Additional honors include: an Army Commendations Medal, Army Achievement Medal with Oak Leaf Cluster, Army Reserve Component Achievement Medal with Oak Leaf Cluster, National Defense Service Medal, NCO Professional Development Ribbon, Army Service Ribbon, Mississippi Medal of Efficiency, Mississippi War Medal, and the Mississippi Longevity Medal with Oak Leaf Cluster.

Commissioner Epps has received three separate Mississippi House of Representatives and Senate commendations: House Concurrent Resolution 114 recognizing him for dedicated and outstanding service to the MDOC and recognition for being the longest serving commissioner in the history of the agency, 2009; House Concurrent Resolution 143 upon his national acclaim and respect of his peers as evidenced by his election as the 102nd President of the ACA, 2011; and Senate Concurrent Resolution 551 saluting him during Black History Month as the longest serving Mississippi Department of Corrections commissioner and as the recipient of the Michael Francke Award, 2012.

A native of Tchula, Mississippi, Commissioner Epps earned a bachelor's degree in elementary education from Mississippi Valley State University and a master's degree in guidance counseling from Liberty University in Lynchburg, Va.

He currently is a deacon at the Hanging Moss Road Church of Christ in Jackson, Mississippi. He is married to Catherlean Sanders Epps, and they have two sons, Chris and Tracey.

DEPUTY COMMISSIONERS



Richard D. McCarty has served as the Deputy Commissioner of Administration & Finance since January 1999. Prior to his appointment to Deputy Commissioner, Mr. McCarty was the Fiscal Comptroller for the agency. Mr. McCarty has worked for the Mississippi Department of Corrections since June 1989. He received a Bachelor of Science in Accounting from Belhaven College in 1983. After graduation, he worked in the field of public accounting. He received his CPA License in 1986 and is a member of the Mississippi Society of Public Accountants.



Jerry Williams is the Deputy Commissioner of the MDOC Community Corrections Division. Prior to this assignment, he served in the following capacities for MDOC: Community Corrections: Region III -Community Corrections Director responsible for 30 counties and five (5) residential facilities and MDOC liaison for one (1) contractual transitional facility, Branch Director II-American Correctional Association Manager for Community Corrections; MDOC Central Office: Operation Management Analyst Principle; CMCF: Correctional Commander, Correctional Supervisor/MDOC Liaison for Offender Health Care Services, Sergeant and Correctional Officer.

Williams is a graduate of Jackson State University in Jackson Mississippi, with a BA in Sociology and MA in Sociology with an emphasis in Criminal Justice. He has served on the advisory board of several community organizations and is an Executive Gold Member with the American Correctional Association.



Emmitt L. Sparkman, a native of Alto, Texas, received his Bachelor of Science Degree from Sam Houston State University and Masters Degree from Eastern Kentucky University. He began his career as a Correctional Officer with the Texas Department of Corrections. During his career, Deputy Commissioner Sparkman has worked in both the public and private sector of community and institution corrections and held positions in Texas, Kentucky and Mississippi. His employment experience includes: Correctional Officer, Education Director, Adult Probation Officer, Juvenile Intake Supervisor/Detention Superintendent, Director of Security,

Warden and Superintendent. He also serves as the Superintendent of the Mississippi State Penitentiary. Mr. Sparkman has been involved in the American Correctional Association Accreditation process since 1992 and has served as a national auditor for the Association since 1995.

CORRECTIONAL TERMINOLOGY

A&D - Alcohol and Drug Treatment Program

ABE - Adult Basic Education; educational classes designed to improve the academic functioning level of offenders whose grade equivalency is 4.0 – 8.9.

ACA - American Correctional Association

Custody Class

Minimum Custody - This custody affords the offender a more relaxed atmosphere and extension of privileges and requires the ability to work satisfactorily with minimum supervision or security control. Minimum custody offenders will be placed in one of the following statuses:

- Community Minimum Status - This custody has the least security and supervision required of an offender. Usually this type offender works in the community.
- Non-Community Minimum Status - This custody has the least security and supervision required of an institutionalized offender and usually housed under minimum security circumstances. The offender may participate in activities on institutional grounds without direct supervision, but must be supervised by trained correctional staff when off grounds.

Medium - This custody is where the offender has displayed a desire to be considered responsible presents a moderate risk. Offenders are housed in a medium security facility and permitted to move about the housing unit or security work area, but are within direct observation of correctional staff. Offenders are under direct/constant armed correctional supervision when engaged in activities outside the perimeter of the correctional facility.

Close - This custody is the highest risk general population inmate and requires close supervision where the offender must be under positive security control at all times. The offender must be under armed supervision outside the perimeter.

"DR" - Death Row

ERS (Earned Release Supervision) - A program whereby offenders eligible under State Code criteria may earn their conditional release to community supervision by the accrual of predetermined good conduct and performance credits.

GED (General Educational Development) - A program to prepare offenders whose grade equivalency is 9.0 – 12.0 for the GED test provided through the GED Testing Services of the American Council on Education.

ISP (Intensive Supervision Program) - Also referred to as House Arrest, requires electronic monitoring and restriction to one's home while not working or otherwise engaged in scheduled programs/activities approved by the supervising field officer.

Literacy - Educational classes designed for low functioning at a grade level of approximately 3.9 or below.

Medical Class

One - The offender is able to work in any job to which he is assigned.

Two - The offender may do light outdoor work to include light lifting (10-15 pounds), some construction work, etc. Offenders in this class are unable to perform logging, heavy lifting, and/or strenuous field-work.

Three - The offender may do any type indoor work to include cleaning, lifting, etc. The offender can not have direct exposure to sunlight.

Four - The offender may do light indoor work to include clerical or other deskwork, etc.

Five - The offender is medically unable to work. The offender must sign an authorization/waiver to be allowed to work at any job.

Offense Types:

Aggravated Assault - Causing or attempting to cause serious bodily injury purposely, knowingly, or recklessly under circumstances manifesting extreme indifference to the value of human life, or by use of a deadly weapon or other means likely to cause death or serious injury.

Burglary - The entering of a building or occupied structure, or separately secured or occupied portion of said structure, for the purpose of committing a crime.

Drug Offense - An offense involving the illegal manufacture, transportation, sale, distribution and/or possession of intoxicants and/or mood altering substances.

Homicide - The killing of one human being by another. Criminal homicide is purposely, knowingly, recklessly, or negligently causing the death of another. Criminal homicide includes murder and manslaughter.

Manslaughter - The unlawful killing of another human without malice and without premeditation or deliberation. It can be voluntary—upon sudden quarrel or heat of passion, or involuntary—unintentionally done while committing an unlawful act, or a lawful act without due caution.

Property Offense - Any offense, not in the categories of sex or drug offenses, that involves the unlawful taking, destruction, sale and/or receipt of property, be it personal or public.

Robbery - The taking of money or personal property, in the possession of another person, from his person or immediate presence, against his will by force or by putting him in fear.

Sex Offense - Any offense that involves any illegal act of a sexual nature, involving illegal physical contact for the gratification of lust and/or engaging in other specific illegal activities for the purpose of sexual arousal.

Violent - Movements or actions characterized by physical force, especially by extreme and sudden or unjust or improper force.

Primary Offense - The offense (normally the most severe offense) that is listed as the first offense in the offender's current record.

Recidivism - A condition that results when an offender that has served a period of incarceration is subsequently released and re-offends with a resulting sentence.

Release Types:

Sentence Expiration - The term of incarceration is completed without any conditional release (i.e. parole, ERS)

Parole - The offender is released prior to the end of the term of incarceration by a decision of the State Parole Board. During the remainder of the sentence the offender will be bound to a strict set of rules of behavior and movement.

Probation Expiration - The offender exits due to sentence expiration with a period of court mandate probation to follow.

Parole with Probation - The offender is released through parole with a court imposed period of probation that will be imposed upon completion of the period of parole.

Shock Probation - An offender that completes the RID program and is released on probation.

Court Suspension - The sentencing judge reviews the offender's case and determines that the time served and behavior demonstrated merits release. This release type leaves the option to discontinue suspension and renew incarceration.

Discharge by Court - The sentencing judge reviews the offender's case and determines that the time served and behavior demonstrated merits release. This release type does not leave the option to discontinue suspension and renew incarceration.

Probation - The offender exits prior to sentence expiration with a period of court mandate probation to follow.

ISP/Probation - The offender is released to Intensive Supervision with a period of normal probation to follow.

RID on Street - The offender is released prior to the end of RID program participation and is subject to probation requirements.

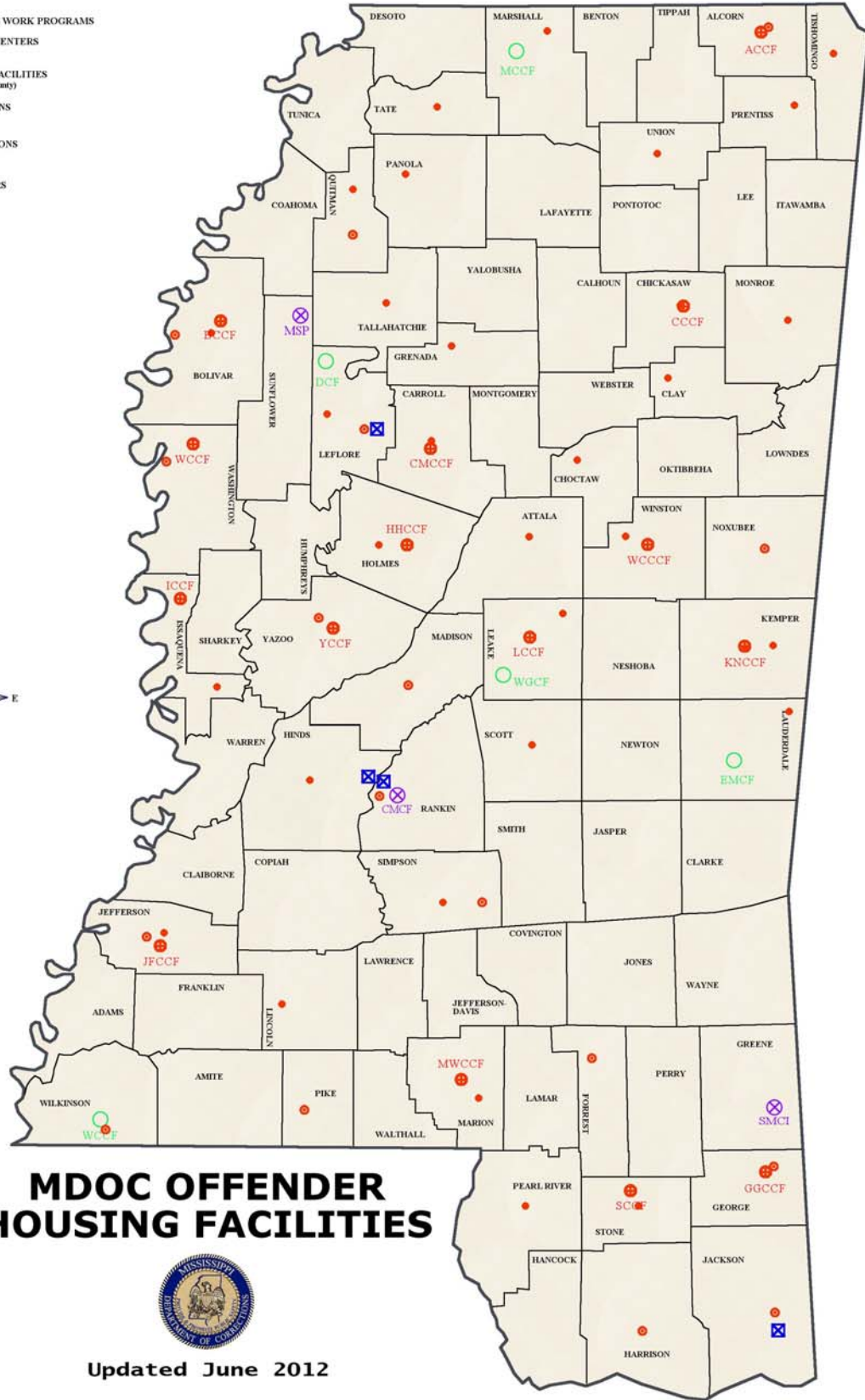
Deferred – The offender, with cause, is released for a period with the remainder of the sentence left to serve.

Regimented Inmate Discipline (RID) - A shock probation program that offenders may be sentenced to in lieu of a longer stay in a conventional prison. Also referred to as Boot Camp.

Sentence Length Less Than One Year – These sentences result from judges imposing split sentences. To be sentenced to the MDOC by law the sentence shall be one year or longer; however, a judge may impose a sentence of a year or more with a portion suspended or otherwise. This results in a sentence length with regard to incarceration that is shorter than one year, but is still in compliance with the law for sentencing the offender to the MDOC.

COMMUNITY CORRECTIONS

Programs

The Division of Community Corrections is charged with the supervision of offenders that are under the jurisdiction of the state. The division conducts field supervision of offenders and oversees a variety of programs that afford offenders an opportunity to re-assimilate into the community. This Division is led by Deputy Commissioner Jerry Williams.

Field Services

The Field Services component of the Division of Community Corrections is responsible for the supervision of offenders released on parole, intensive supervision (ISP), earned release supervision (ERS), medical release and those sentenced by the court to probation or ISP.

F.R.E.E. (Facing Reality Educationally and Emotionally)

The MDOC Division of Community Corrections has thirteen F.R.E.E. program coordinators located statewide that assist field officers in monitoring offender's treatment needs for substance abuse. In addition, program coordinators teach a structured life skills curriculum twice a month to assist offenders in other areas of their life that have been affected by their substance abuse problems.

Interstate Compact

The State of Mississippi participates in the Interstate Compact for Adult Offenders. Under the terms of the compact agreement, the Mississippi Department of Corrections (MDOC) provides courtesy supervision to probationers and parolees from other states in exchange for courtesy supervision of Mississippi offenders residing in other states.

Pre-Trial Diversion

The Pre-Trial Diversion program is an alternative to felony conviction in which a defendant voluntarily submits to supervision ranging from six months to three years. Charges against the offender may be dismissed if the period of supervision is successfully completed.

Intensive Supervision Program

The Intensive Supervision Program (ISP) is designed to provide a level of supervision in a community setting to offenders who would otherwise be incarcerated. Offenders are required to wear electronic monitoring equipment and are limited in most cases to employment, treatment, and worship services activities. Each offender in ISP maintains inmate status and can be immediately placed in an MDOC facility upon violation of the program.

Drug Testing

Community Corrections field officers are responsible for routine and reasonable suspicion drug testing of offenders and random drug testing of 15% of the offender population each month.

Programs

Restitution Centers

There are four Restitution Centers in Mississippi that assist residents in obtaining employment as a condition of their probationary sentence. Money earned by residents is distributed to crime victims for restitution, courts for court costs and fines, and MDOC for room and board. The remainder of the resident's wages, after taxes, goes to the resident's family or to the resident's holding account. Upon completion of the program, residents are transferred to a field officer and remain under supervision for the remainder of their probationary sentence.

Community Work Centers

The MDOC Community Corrections Division oversees 17 Community Work Centers throughout Mississippi. Minimum security inmates are assigned to these centers and are provided a gradual, re-introduction into community life. The program includes alcohol and drug counseling, Adult Basic Education and GED preparation, literacy classes and religious programs.

Each Community Work Center houses approximately 102 inmates that perform a wide range of labor at no cost to city, county and state government agencies and to school districts. This work ranges from community beautification projects to bridge and road work repair, vehicle maintenance, and water, sewer, and sanitation details.

Inmate Labor

The offenders that serve their sentences in Community Work Centers provide free labor to municipalities, counties and other state agencies. A sample of the work they perform includes highway beautification, facility maintenance, road work, and equipment maintenance. In FY 2012, the offenders in the community work centers provided entities with 2,451,393 total inmate hours, valued at minimum wage to equal \$17,772,600 in free labor. For the same 12 months the residents in the restitution centers provided entities with 24,622 total resident community service work hours valued at minimum wage to equal approximately \$178,510 in free labor.

Mississippi Prison Agriculture Enterprises

One mission of the farm program is to decrease inmate idleness and to cut budget costs for the taxpayer. During FY 2012, inmates worked 600,000 hours in the agriculture program.

For the crop year 2012, Agriculture Enterprises planted approximately 1,313 acres of vegetables, 100 acres of rice, 498 acres of corn, 566 acres of wheat and 3,245 acres of soybeans.

The poultry facility is in full production with a 36,000-layer capacity. A total of 476,804 dozen eggs were delivered to MDOC food services with a non-cash value of \$483,331 in FY 2012.

The inventory of commodities carried over from FY 2012 had a value of \$222,105. This figure includes feed mill inventory, seed, fertilizer, and chemicals not expended during FY 2012.

Non-cash sales for FY 2012, vegetables and egg sales were \$1,836,344. The total pounds of vegetable non-cash sales for FY 2012 was 2,873,143. Egg sales consist of 476,804 dozen.

Vegetable value is based on the USDA Atlanta Market Report. All processed vegetables and eggs were provided to the MDOC Food Service Department. MPAE sold vegetables to employees to generate cash dollars of \$4,536.00.

On June 30, 2012, the Agricultural Enterprises Special Fund had a balance of \$529,177.71. Cash income received for Agricultural Enterprises, including deposits in transit, totaled \$2,570,913.34.

MPAE completed construction of the feed mill during FY 2002 year. The three 42,000 bushels grain bins are used for on-farm storage of corn grown by MPAE and is utilized by the feed mill. This is a cost savings on outside storage and trucking fees. The total cost of the feed mill was \$864,394.81. During FY 2012, the feed mill produced 9 different feed rations for chicken consumption. They produced 2,190 tons at a price to livestock of \$566,564.29.

The work staff includes 16 positions. At the present time 14 positions are filled and MPAE has four (4) contract employees.

Treatment Programs Alcohol and Drug

Mission Statement: The mission of the Alcohol and Drug (A&D) Program is to provide treatment and rehabilitation services to offenders who have a history of substance abuse problems or who commit alcohol and drug related crimes. The goal is to correct the offender's attitude and behavior that supports criminal thinking.

Mississippi State Penitentiary

Unit 30 A-B: The Alcohol and Drug Therapeutic Community Treatment Centers (ADTC-TC) at Unit 30 total 432 therapeutic community treatment beds. Unit 30 consists of two housing buildings (Buildings A and B), with two housing zones in each of the two buildings (Zones A & B). Each housing zone accommodates 108 offenders. Adjacent to each housing building is clinical staff office space. Group rooms and classrooms are in the Unit 30 compound.

The Therapeutic Community Program is a long-term program only. Offenders must have at least six to thirty months remaining on their sentence to enter the program.

Unit 31: This is a traditional 12-Week A&D Program based on the principles of Alcoholics Anonymous offered at Unit 31 for special needs (disability) offenders.

Central Mississippi Correctional Facility

This is a 12-week traditional Alcohol and Drug Treatment in operation for female offenders at the Central Mississippi Correctional Facility (CMCF). A long-term program (6 months to 12 months) is also available at CMCF for female offenders. In addition, a 12-week Treatment Program is also available at CMCF for special needs (disability) male offenders.

South Mississippi Correctional Institution

A traditional Alcohol and Drug Treatment Program was started in June 2000 at the South Mississippi Correctional Institution (SMCI), Leakesville, Mississippi, for general population offenders. This program is 12 weeks in duration. It was started primarily for Judicial Review cases that do not have six months remaining on their sentences upon entry to the Central Mississippi Correctional Facility (CMCF), Pearl, Mississippi, the point of entry for inmates into the Mississippi Prison System.

This program also serves parole and ISP offenders.

In addition, SMCI provides an Alcohol and Drug component in the Regimented Inmate Discipline (RID) Program. In September 2005, a long-term (6 months) program was started for general population offenders. In July 2006, a short-term (12 weeks) A&D program was implemented for CWC returnees. The CWC program has been changed to 4 weeks in duration.

Community Pre-Release Centers

The Residential Substance Abuse Treatment (RSAT) Program is operated in the Flowood, Pike and Quitman Community Pre-Release Centers for offenders who are within six months to one year of release. The offenders provide work in the community during the day and attend Alcohol and Drug classes in the evening.

Flowood Community Work Center

A twelve-week A&D program is offered at the Flowood Community Work Center for female offenders who are expiring their sentence, paroling or are being released on Intensive Supervision Program (ISP).

Community Work Centers

Alcohol and Drug Treatment Programs based on the principals of Alcoholics Anonymous are offered in 14 Community Work Centers. Offenders provide work in the community during the day and attend evening treatment sessions weekly.
