# SB 2273 (2022)

This legislation, passed during the Mississippi 2022 Legislative Session, allows employers to submit timesheets, proof of ongoing employment, and results of required drug tests in lieu of in-person or electronic meetings for those individuals who are on community supervision and working. This legislation also allows employers to withhold and pay directly to MDOC earnings from the individual who is working to cover the monthly \$55 community supervision fee as set by statute.

# **Proper Identification**

### SB 2263 (2022)

This legislation, passed during the Mississippi 2022 Legislative Session, prohibits physically incarcerated offenders from requesting a name change. A name change may only occur if one of the following individuals files a change of name petition on behalf of an offender: a district attorney, a sheriff of a county in which a person is incarcerated, the Commissioner of MDOC (or designee), an MDOC Chaplain.


# **Necessary Skills**

#### Skill UP Mississippi

Skill UP Mississippi is an initiative of the Office of Adult Education within the Mississippi Community College Board. Some of the programs within the initiative include: 1) High School Equivalency; 2) **Smart Start**; 3) English as a Second Language.

#### **Smart Start**

Smart Start is designed to help students gain the skills they need to be successful in today's economy. The program prepares students for middle-skill jobs such as machinists, registered nurses, computer technicians, medical assistants and a host of other opportunities by helping them learn and practice good work habits and the effective communications skills needed to secure meaningful employment.



Smart Start students are prepared to take the ACT WorkKeys test (including Applied Math, Graphic Literacy, and Workplace Documents) that qualifies students for the National Career Readiness Certificate (NCRC). Employers seek candidates with an NCRC regardless of the candidate's educational background. The certificate signals to employers that students have the skills necessary to be effective in a job. # HB 1313 (2022)

This legislation, passed during the Mississippi 2022 Legislative Session, created the "State Representative Bill Kinkade Fostering Access and Inspiring True Hope (FAITH) Scholarship Program. Commencing with the 2023-2024 Academic Year, scholarships are available to eligible foster youth to pay up to the cost of attendance at any approved postsecondary educational institution for any certificate or degree program.

# Mississippi Fresh Start Act of 2019

The intent of this act is to expand work opportunities for people who were formerly incarcerated by revising the restrictions on occupational licensing based on criminal records. It also provides that an individual with a criminal record can petition a licensing authority before entering a program of study to determine if the individual's criminal record will disqualify them from obtaining a license. # **WIOA On-the-Job Training**

Helps businesses hire and train workers by reimbursing a portion of expenses incurred during the initial training process. For more information, contact the local WIN Job Center.

# **WIOA Individual Training Account**

Workforce grants that provide funding for educational/occupational skill training for eligible job seekers. For more information, contact the local WIN Job Center.

# Rapid Response

An early intervention service that assists both employers and employees affected by layoffs or plant closures. It provides access to user-friendly resources and information to help transition affected workers into reemployment. For more information, contact the local WIN Job Center.

### Trade Adjustment Assistance (TAA)

A federal program that helps U.S. workers who have lost or may lose their jobs as a result of foreign trade. This program provides workers with opportunities to obtain the skills, credentials, resources, and support necessary to become re-employed. For more information, contact the local WIN Job Center.

#### Senior Community Service Employment Program (SCSEP)

An employment and training program for Mississippians aged 55 years and older. The program provides subsidized, part-time work experience for a limited time through community service, enabling seniors to obtain the skills necessary for permanent employment. Participants in the program learn new skills and talents or enhance existing ones to become competitive in today's workforce. For more information, contact the local WIN Job Center.

#### **Registered Apprenticeship**

An industry-driven, high-quality career pathway where employers can develop and prepare their future workforce, and individuals can obtain paid work experience, classroom instruction, and a nationally recognized, portable credential. The five key components of the program include the following: 1) a paid job; 2) work-based learning; 3) mentorship; 4) classroom learning; and, 5) credentials. ### **Opioid National Dislocated Worker Grant**

Provides dislocated workers and long-term unemployed individuals with career and supportive services, training, and disaster relief employment in careers that will mitigate the effects of the opioid crisis. For more information, contact the local WIN Job Center.

#### **COVID-19 National Dislocated Worker Grant**

Disaster -relief employment for humanitarian assistance to vulnerable and underserved populations; distribution of essential supplies; and assisting law enforcement, public health, workforce, and social service agencies with humanitarian assistance. For more information, contact the local WIN Job Center.

### Work Opportunity Tax Credit (WOTC)

A federal income tax credit for employers who hire individuals who face obstacles to employment. The tax credit may range from \$1,200 up to \$9,600, depending upon the target group and other factors of the employee. Target groups include Ex-Felons, Long Term Unemployed, SNAP Recipients, SSI recipients, Veterans, Vocation Rehabilitation referrals, SSI Recipients, Summer Youth, and others. #### **Fidelity Bonding Program**

A free insurance bond designed to help reduce the risks of hiring individuals whose criminal backgrounds pose barriers to securing employment. Individuals with criminal records, including individuals recovering from opioid and other drug addictions, are eligible for coverage under the bonds. The bond insurance issued to an employer ranges from \$5,000 to \$25,000 coverage for a 6-month period with no deductible amount.

Effective October 1, 2022, all eligible participants must be either a custodial parent, or a non-custodial parent with a support obligation, for at least one dependent child.

# **Voter Registration**

Every U.S. citizen who possesses the following qualifications is eligible to register to vote in Mississippi:

- A resident of Mississippi and the county, city, or town for 30 days prior to the election;
- At least 18 years old (or will be 18 by the date of the next General Election);
- Not declared mentally incompetent by a court; and
- Not convicted of a disenfranchising crime as defined by Section 241 of the Mississippi Constitution or by Attorney General Opinion, unless pardoned, rights of citizenship restored by the Governor, or suffrage rights restored by the Legislature.

The Mississippi Secretary of State provides a list of **disenfranchising crimes** (i.e., crimes that restrict voting after completion of sentence) on its website:







#### What is the Career STEP Program?

The Career Skills Training Education Pathways (STEP) Program is a workforce program that covers the cost of short-term (less than one year) training, such as workforce and career-technical education courses. The program partners with local community colleges to connect participants to training opportunities and ultimately to career pathways.

#### What are the eligibility requirements?

Participants must be between ages 18-59 with a household income not exceeding 200 percent of the federal poverty level, Participants may not be in high school, Career STEP staff members, including Regional Career Navigators and Career Coaches, can assist potential participants in calculating household income

#### What are some of the training opportunities?

Each community college offers a number of short-term training courses. For example, a college may offer a Commercial Driver's License (CDL) training course, a welding course, or the training necessary to become a Certified Nurse Aide (CNA) or Emergency Medical Technician (EMT). Participants are encouraged to explore the options offered by each college to find their preferred pathway. Participants may also speak with a Career STEP staff member to arrange a screening to determine a program that would be a good fit for the participant.

#### Does the program assist with other expenses?

Yes. In addition to tuition costs, the Career STEP Program can pay for support services such as books, tests, lab supplies, or tine cost of any certifications or licenses necessary for the participant to gain employment.

#### What else is offered through the Career STEP Program?

Career STEP staff members can help participants with resume writing, job search endeavors, career counseling, assessments, workforce preparation skills and assisting in the successful completion of the ACT National Career Readiness Certificate (NCRC), an evidence-based credential that certifies the essential skills for workplace

#### How will the Career STEP Program assist participants once training is complete?

Career STEP staff members work closely with industry partners to build internship programs that further develop knowledge and career readiness. Paid internships, which are funded through the program, are available for many of the programs of study.

#### How is the program funded, and what is its service area?

The program is funded through Temporary Assistance for Needy Families (TANF) federal funds awarded to the Mississippi Department of Human Services. Southern Mississippi Planning and Development District acts as the fiscal agent for the Twin Districts Workforce Development Area, the 24-county service area served by the program. The colleges inside of the area include East Central Community College, Meridian Community College, Jones College, Pearl River Community College and Mississippi Gulf Coast Community College.
