115.11 Zero tolerance of sexual abuse and sexual harassment; PREA coordinator Auditor Overall Determination: Meets Standard **Auditor Discussion** The facility's policy, Prison Rape Elimination Act specifies zero tolerance of sexual abuse and harassment. The agency policy specifically outlines procedures that allow sexual abuse and harassment that occur within the facility to be detected, reported, and prevented. Based on interviews with both inmates and staff, it has been concluded that the policy is being implemented and sexual safety is taken very seriously at KCRCF. Every standard and all prohibited acts are outlined in a clear and precise way within the policy, allowing little to no room for confusion of what is expected. The MDOC state-wide PREA Coordinator and facility PREA Compliance Manager were familiar with their respective responsibilities to ensure compliance to policies by staff. The organizational chart is provided to accurately indicate the chain of command and PREA being assigned as an upper management responsibility. The KCRCF Compliance Manager indicated that she has sufficient time and authority to coordinate the facility's efforts to comply with the PREA standards as required. She stated the Warden allows her the autonomy to maintain compliance with implementing necessary procedures. The agency addresses its policy against sexual abuse and sexual harassment in the Inmate Handbook, Staff PREA training and an array of educational material provided to staff and inmates throughout the

115.12	Contracting with other entities for the confinement of inmates
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	From documentation provided and interviews amongst facility leadership, it was determined that the facility does not contact with other facilities to house inmates assigned to their custody. Per the agency's written agreement with MDOC, through the confinement of inmates designated to KCRCF, inmates will be returned to the MDOC for housing only. KCRCF does not contract for the confinement of inmates. This standard did meet all requirements, despite contracting for inmates not being applicable to KCRCF.

115.13	Supervision and monitoring
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	Auditor reviewed all aspects of the staffing plan prior to site review. During the onsite visit, the plan was discussed with the Warden and PREA Compliance Manager and it is noted that all aspects of the standard are considered when developing and reviewing the staffing plan. The facility has documented any deviations from the staffing plan. Any time the plan is not followed, the Chief of Security notified, and it is documented. Shift rosters are reviewed daily to monitor shift coverage. The plan is reviewed annually by the senior members of the staff to include the PREA Compliance Manager, Sheriff and Warden and any recommendations are sent to the MDOC PREA Coordinator. The facility utilizes two 12 hour shifts consisting of security and supervisory staff in addition to 24 hours of extensive video monitoring. The video monitoring has a 30 day retention to allow for review of any alleged incidents reported. Each area of the facility is evaluated annually by the Warden to determine any blind spots. The supervisors are required to make unannounced rounds. Documentation review and interviews indicate this is a common practice for this facility. In addition to facility staff review annually, the departmental PREA Coordinator also reviews the staffing plan. Intermediate
	and higher-level staff are required by facility policy to conduct and document unannounced rounds. The rounds are documented in the control unit log book and are identified as unannounced rounds. This process was verified through inmate and staff interview as well as facility register logs.

115.14	Youthful inmates
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	KCRCF does not house youthful inmates. This standard is not applicable to KCRCF since the population consist of adult males only. Therefore, the facility meets this standard.

115.15 Limits to cross-gender viewing and searches

Auditor Overall Determination: Meets Standard

Auditor Discussion

Policy covers the procedures for searches and is compliant with the mandates of this standard. This facility does not house female or youthful offenders. The facility does not conduct cross-gender strip searches and/or cross gender body cavity searches, and this was verified through staff and inmate interviews. During the interview process, it was noted that staff acknowledged receiving training on conducting cross gender pat down searches.

Appropriate policies and training curriculums are in place to address cross-gender searches. There have been no exigent circumstances of cross-gender searching, but polices to address this, are in place as well. Training is provided that covers each area of the standard. Documentation review and interviews verify the training is conducted and understood by employees. Established policies prohibit staff from searching or physically examining a transgender or intersex inmate for the sole purpose of determining the inmate's actual genital status.

Cameras are strategically located through-out the facility to ensure inmate privacy, while maintaining a secure environment. Staff of opposite sex are required to announce their presence prior to entering housing areas, and this was observed during the onsite review. In addition, the inmates interviewed verified cross gender announcements are a regular practice at KCRCF. Although there have been not transgender inmates at the facility, applicable policies are in place and training records indicate that staff are familiar with searching procedures with this population.

Barriers in the toilet areas and in the shower area allow for inmate privacy, while not infringing upon good security practices. Lastly, interviews with inmates revealed no concerns with cross-gender viewing during shower and/or bathroom use. During the interview process, there were no concerns relating to cross gender viewing during showering or toilet use. Every inmate interviewed voiced the feeling of safety at KCRCF.

In housing area Zone F, the control room officer had a visual of the observation cell separate from the camera view. In addition to the observation cell, there was one toilet she had direct physical view of from her post. The toilet area has a curtain that is supposed to be used by inmates to cover the toilet; however, at the time of onsite review, the curtain was not being used. Staff stated the toilet was not working at the time (request for repair had been submitted) and no inmates were observed attempting to use toilet while auditor was present. Inmate interviews verified toilet had not been in use for some time. The camera system has a black box for a privacy view on all angles and areas of the restroom area with the exception of one shower view.

Corrective Action: Implement frosting/cover on bottom half of window of observation cell to provide privacy for offender when using restroom. Have the shower and toilet view digitally obscured on the monitoring system (all showers have curtains). Post additional notice to inmates in zone instructing them to close curtain if using the toilet in view (the other toilets could not be seen by officer). Provide auditor with verification of implementation via photograph of observation window, addition of privacy view on camera system and memo to inmates regarding the placement and use of curtains.

Completed Corrective Action: The frosting was placed on the window prior to end of audit and placement was verified by auditor. The notice to inmates instructing the curtain to remained closed when toilet is in use was placed in multiple areas in the dorm, visible to all inmates. This notice placement was verified by auditor. The only corrective action remaining item is to digitally obscure the one view of the shower on the officer's computer. The facility has reached out to the company with the capability to fix this and will send video or pictures once complete.

Corrective Action update: The facility sent pictures to the auditor to verify the view of the shower has been digitally obscured. The facility is compliant with this standard.

Inmates with disabilities and inmates who are limited English proficient
Auditor Overall Determination: Meets Standard
Auditor Discussion
Agency policy prohibits the use of offender interpreters to gather information related to an allegation of sexual abuse or sexual harassment. Due to the population housed at KCRCF, it is unusual for an inmate to have a significant physical impairment or cognitive disability. Any offender requiring special accommodations would not be transferred for housing at KCRCF.
Policies are in place to ensure that inmates with disabilities are equally able to benefit from the efforts of the facility to prevent and investigate any occurrences of sexual abuse or harassment. Additionally, inmates with problems communicating are able to benefit from the facilities available resources to ensure effective communication, regardless of language and/or level of understanding. The facility has two staff members that are qualified to provide services to any inmate with language barrier.
During onsite review, the auditor was able to interview inmates with special needs.

115.17	Hiring and promotion decisions
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	Policy reviews and interviews with HR personnel verified that this facility does not hire, promote or enlist the services of any contractor that may have contact with inmates, if the said party has committed or been convicted of any of the prohibited acts as defined in sections 1-3 of Standard 115.17(a), or had any incidents of sexual harassment. New prospective employees/contractors are subjected to criminal background checks through the NCIC System (every five years). The HR manager verified that each employee is reviewed on a monthly basis while monitoring timesheets. Any employee that needs an updated background check is submitted to Warden or Kemper Sheriff office for background check to be completed. All employees had an updated NCIC report completed in 2021. New hires and employees applying for promotion are specifically asked about misconduct through a separate reporting form. Requests by employers, concerning former employees, is responded to by HR staff. By law, the facility is prohibited from providing any information concerning a substantiated allegation of sexual abuse or sexual harassment by a former employee

115.18	Upgrades to facilities and technologies
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	The facility reviews all areas including blind spots to determine the need for additional camera coverage on an annual basis. The video monitoring system installed has the clarity to monitor activities within the housing zones and other facility areas with clear lines of sight and coverage. The Control Center Officer has access and is assigned to monitor the 74 cameras, the cameras have great
	visibility and the view of the bathroom area is unable to be seen via camera angle.
	The modifications made during the last audit consisted of an upgrade from analog to digital for all of the cameras. During the interview with the Warden, he indicated that all areas of the facility are reviewed annually to ensure camera placement is appropriate and designed to increase and enhance the facility's sexual safety. The facility reviews all areas including blind spots to determine the need for additional camera coverage on an annual basis. The video monitoring system installed has the clarity to monitor activities within the housing zones and other facility areas with clear lines of sight and coverage. The Control Center Officer has access and is assigned to monitor the 74 cameras. Staff as well as inmates confirmed during interviews that they felt safe and secure with the camera system. During the site review, it was obvious that almost every area of the facility can be viewed while still enabling the privacy of the inmates while dressing, showering and toileting.

115.21	Evidence protocol and forensic medical examinations
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	The facility has a certified law enforcement officer who has recently assumed the responsibilities as the investigator. However, since he has not yet completed the specialized training, the Warden serves as the current investigator. Warden Jowers who is a certified law enforcement officer has been utilized as the sole facility investigator and now serves as the head Warden. A uniform evidence protocol is used during the investigative process that maximizes the potential for obtaining usable physical evidence. Any reports of criminal violations are immediately submitted to the District Attorney office for prosecution. There have been no reports of sexual abuse, sexual harassment or sexual assault at KCCF and no investigation conducted. Verified in interviews and through documentation, the individual conducting the investigations has received the required specialized training through the Mississippi Law Enforcement Academy. Warden Jowers is also trained in interview and interrogations. In the case of an investigation determined to be administrative, the Warden and Captain work together to investigate the incident and notify CID at MDOC if necessary. There have been no forensic medical exams conducted in the past 12 months due to there being no incidents. Anyone who alleges sexual assault will be offered access to forensic examination at no cost at John C. Stennis Memorial Hospital, where a SAFE/SANE is available as referenced per the facility's Memorandum of Understanding. A trained victim advocate is made available as documented in an MDOC Memorandum of Understanding with the Mississippi Coalition Against Sexual Assault (MCASA). According to the MOU, the service provides for the advocate to be designated as the statewide DOC Victim Advocate.

Auditor Overall Determination: Meets Standard Auditor Discussion There have been no allegations of sexual abuse or harassment in the past 12 months. Agency policy mandates immediate initiation of an investigation following an allegation of sexual assault. The policy states the agency shall follow a uniform evidence protocol when conducting the investigation. This standard was addressed in KCRCF policy, the PAQ, and during an interview with the investigative staff. All allegations of sexual abuse and sexual harassment reported by inmates, staff, third party, volunteers and/or contractors must be submitted to the proper investigative staff for investigation. All requirements of the standard are outlined in the policy published on the Mississippi Department of Corrections website as required. The interview with the investigator indicated the Sheriff's office and the facility work together to maintain compliance with this standard. The investigator indicated he would be notified immediately and would follow alleged victim to John C. Stennis Memorial Hospital to initiate investigation as soon as possible. The communication between the facility administration and the Sheriff office is commendable and beneficial to both entities.

115.31	Employee training
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	Prior to the onsite portion of the audit, the auditor reviewed the training curriculum in addition to employee training rosters. While onsite, the audit reviewed additional rosters indicative of all staff completing the agency required training.
	All full and part time staff at KCRCF receive PREA training upon being hired. The training curriculum covers the specifics outlined in this standard, in addition to first responder training. All staff voiced receiving training but not all staff could easily articulate specifics of training and some not familiar with first responder duties. It seemed that although the concept of PREA was recognized, the details regarding duties and ways to report were not common knowledge amongst staff.
	All training is tailored based on the all-male inmate population. Documentation reviews reveal that training records and staff training transcripts are maintained in the Warden's office.
	Corrective Action: Provide a refresher training to all staff via roll call trainings. Submit verification of refresher training to Auditor.
	Completed Corrective Action: The facility provided an agenda with dates of an additional training that extended past the time allotted in roll call. The signed rosters from each shift were also submitted. The facility is in compliance with this standard.

115.32	Volunteer and contractor training
	Auditor Overall Determination: Meets Standard
İ	Auditor Discussion
	All contractors and volunteers who may have inmate contact receive training on their responsibilities regarding the facility's sexual abuse and harassment prevention, detection and response policies and procedures. All contractors and volunteers received the required initial and annual refresher training. During the onsite portion of the audit, training records and signed acknowledgment forms were reviewed by the auditor. The Chaplain indicated he conducts the annual training for the volunteers and covers all necessary content for training. There were no volunteer trainings during Covid but the one volunteer interviewed verified training took place prior to utilization of services. The training verification is kept in the Administration office with the Chaplain maintaining a copy.

115.33	Inmate education
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	Prior to arrival at KCRCF, all inmates are required to receive the PREA-required education and information concerning sexual safety to include reporting, response and retaliation. The information is provided at the MDOC Reception Center and the training/education is documented in the MDOC electronic inmate files.
	During intake process at KCRCF, inmates receive information explaining the zero-tolerance policy and how to report incidents or suspicions of sexual abuse or harassment. Much of this information is also provided by the Booking Officer in a pamphlet format at Intake. The Booking Officer and the Nursing staff are both involved in the intake assessment to determine risk for victimization. Upon arrival, every inmate has already completed the detailed assessment at the reception unit and are reassessed when they arrive to KCRCF. To date, the facility has not received any inmates designated as high risk for sexual victimization, per the reception assessment. This is not uncommon due to the population the facility typically houses. There are adequate postings and signage strategically located throughout the facility, readily and continuously available in English and Spanish if needed. Random inmate interviews indicated that inmates have knowledge of PREA as well as acknowledgement receiving the education at the Reception Unit prior to arriving at KCRCF. Normally, KCCF does not receive inmates who have limited English proficiency, or who are deaf, visually impaired or otherwise disabled. If it was determined that a newly arrived inmate had significant disabilities, staff are available to personally assist with accessing services through MDOC or Volunteer Staff translator. Generally, these inmates would be immediately transferred to the MDOC for confinement and care. Upon review of inmate files, training curriculum, inmate handbook and PREA pamphlet, it is determined that the facility meets each subsection of this standard. The facility also provides a video for the inmates to watch upon arrival. The inmates are receiving PREA education and their Handbook upon arrival to the facility at intake. During the interview process, inmates verified receiving the information soon upon arrival at the facility. However, most of the inmates were already familiar with PREA prior to arriving at KCRCF.

115.34	Specialized training: Investigations
	Auditor Overall Determination: Exceeds Standard
	Auditor Discussion
	At KCRCF, the lead criminal Investigator is currently Warden Jeff Jowers. The facility recently hired an additional investigator that has exceptional experience in the field of law enforcement and investigations. However, he had not received the PREA Specialized training as of the date of the audit so he did not investigate PREA related concerns. Warden Jowers has 32 years of law enforcement experience and was previously employed with the Sheriff Office before assuming the position of Warden. Warden Jowers has a Bachelor degree in Forensic Science and a Master Degree in Criminal Justice. He has completed numerous trainings regarding the investigative process to include interviews and interrogations. Warden Jowers has conducted sexual assault cases for over 30 years. The policy, training curriculum records and interviews reveal that the investigative staff receive not only the generalized training that other staff receive, but also specialized training in conducting investigations in a confinement setting. Examples of this specific training received are: interviewing sexual abuse victims, proper use of Miranda and Garrity warnings, sexual abuse evidence collections in a confined setting, and the criteria and evidence required to substantiate a case for administrative action and/or prosecution referral. All training documentation is maintained by the facility and it is noted that the training received exceeds requirements for this standard. The current trained investigator is extremely knowledgeable of the investigative process and his level of expertise in investigations is very beneficial to this facility. Although the facility is small, with limited resources, the investigative services are clearly a priority. The Warden articulated the great relationship with the Sheriff office in addition to the partnership with the local District Attorney office. KCRCF exceeds the requirement of this standard due to the extensive training of the current investigator .The facility Captain would begin any administrative inve

115.35	Specialized training: Medical and mental health care
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	Mental Health Services are provided through the Mississippi Department of Corrections, not in an RCF, and an offender requiring such services would be transferred back into the State prison system. Any inmate in need of mental health services would be transferred on an emergent basis and would have the possibility of returning, depending on the reason for transfer. The facility was in the middle of a transition for the medical staff. KCRCF contracts through vital core for medical staff. The agency has not been able to staff the facility in the past month. The previous part time nurse resigned the week of the audit and the previous full time nurse (recently retired) has volunteered to continue her services weekly to assist the physician until the facility is staffed. The nurse who visits facility weekly has received the specialized medical training from the NIC website. The facility does not have onsite mental health staff but instead uses MDOC for telehealth as needed.

115.41 Screening for risk of victimization and abusiveness

Auditor Overall Determination: Meets Standard

Auditor Discussion

The PAQ reports all inmates entered the facility within the last 12 months and all were screened for risk of victimization and abusiveness upon their arrival. Most of the inmates that arrive at KCRCF have recently been screened for victimization/abusiveness at the Reception unit, however; the staff at KCRCF is diligent about conducting an additional screening before placing the inmate in his assigned zone. All factors are considered, and the information is appropriately disseminated to ensure the inmate safety. The inmate is screened upon arrival by the Booking officer followed by an additional screening within 72 hours by the Nurse. However, as of the week of the audit the nurse resigned and the facility is awaiting assignment from Vital Core to fill the vacancy. In the interim, the Captain(who also serves as booking officer) will assume the responsibility of completing the entire screening process. The Captain interviewed was aware of her new responsibilities but a little anxious start the process. As required by the policy and standard, all inmates are screened upon intake at the regional MDOC Reception Facility for their risk of being sexually abused by other inmates or being sexually abusive toward other inmates; they also receive their first reassessment there since they are normally there several months. The screening assessment considers whether the inmate has a mental, physical, or developmental disability, age, build, previous incarceration, prior sex offenses, criminal history, previous victimization, and whether the inmate is detained solely for civil immigration purposes. Any inmates identified by the assessment are retained in MDOC and not sent to an RCF.

At any time an inmate feels unsafe for any reason, he has the option to complete a Red Tag form that will ensure he is no longer housed with the inmate he is avoiding. This information is made a part of his permanent record, easily accessible if he transfers to another facility within MDOC.

In addition to the assessments by the Reception Center staff and facility staff, the RCF Case Manager meets with every offender upon arrival and every thirty days, thereafter. During these meetings, the Case Manager inquires as to any issues the inmate may be having in their assigned zone.

Policy prohibits inmates from being disciplined for refusing to answer assessment questions, or for not providing information in response to the screening tool questions. All information is secured appropriately on a limited access bases, with sensitive information strictly off limits to line staff or other inmates. Information gathered during the assessment, is privileged to staff making housing, work, or program assignments. Screening is accomplished promptly, within the first seventy-two hours after arriving. In accordance with applicable policies and standards, the reassessment tool considers prior data, along with any new information that may have been received.

During the interview with the Captain, it was concluded that her anxiety around being responsible for completing the entire screening process was simply because she was unsure of her role. A recommendation was made to the PREA Compliance Manager and Deputy Warden that the Captain receive an individualized training on the process and screening tool. The PCM and Deputy Warden agreed and will forward the training form once completed.

115.42 Use of screening information Auditor Overall Determination: Meets Standard **Auditor Discussion** If there was an inmate that is identified as high risk either during intake or through screening process, the senior staff would be notified and an individualized determination of how to ensure the safety of each inmate would be decided. The screening form has an indicator at the bottom to recommend the disposition for housing based on the level of risk. The facility can opt to either transfer the inmate back to the state facility or separate in housing and work assignments. In addition, the Cell Bed Assignment sheet is utilized to determine appropriate housing, work assignment, etc. Any information relative to the inmates high risk for victimization or predatory behavior will be considered when completing the Cell Bed Assignment form. Since the new procedure is for the Capt. to complete Based on policy mandates and confirmed through staff interviews, KCCF accumulates information learned during the intake process, along with information gathered during the initial risk screening at the Reception Center and has done this for all inmates received during the past year. Typically, transgender or intersex inmates are not assigned here but reside at a state institution with more resources for housing and programming to ensure these inmates' health and safety. In the event that a transgender or intersex would be assigned to KCCF, policy states that all assignments would be reassessed twice yearly to review safety, with the inmate's own views of safety given serious consideration and this understanding. This information was verified through interviews with upper management staff. Although the facility has not received transgender or intersex inmates, facility policy provides the opportunity to shower separately from other inmates and facility staff were familiar with this requirement.

115.43	Protective Custody
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	There were no instances of use of involuntary segregated housing in the past 12 months for inmates at risk of sexual victimization. KCRCF policy does outline procedures to ensure inmates at risk of sexual victimization are not placed in involuntary segregated housing unless an assessment of all available alternatives has been made.
	Although there have been no incidents or allegations at this facility in the past 12 months, staff interviewed were aware of the requirements of the standard as well as the facility policy. Involuntary segregation is rarely used at an RCF. Inmates placed in involuntary segregation do not ordinarily remain for more than 24 hours pending transfer, unless an exigent circumstance exist. Reviewing practices and interviewing inmates indicated the policy was being followed.

115.51	Inmate reporting
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	According to policy, any staff member receiving a report is required to verbally report that immediately and provide a written report prior to the end of that shift. All interviews with staff indicated this procedure is understood and would be followed in the event of an allegation. The information for the external agency is posted throughout the facility and listed in the inmate handbook; all inmates interviewed were aware of the telephone number posting. Inmates may remain anonymous by using the external agency or by submitting an anonymous letter. Staff knew the methods to report and all interviews stated that they would be comfortable doing so. The agency allows third parties to submit reports of allegations of sexual abuse/harassment on behalf of inmates.
	There are several different avenues provided to the inmate population for reporting purposes. These services include mail, free telephone services to internal offices and external agencies, and directly to any staff member or third party who may report back to the facility. Staff is readily available to the inmate population to receive any complaints.

115.52	Exhaustion of administrative remedies
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	KCRCF is not exempt from this standard and has procedures in place to address inmate grievances regarding sexual abuse. However, there have been no reports of sexual abuse or sexual harassment. Therefore, no grievances have been filed. KCRCF policy addresses the administrative remedy process to be utilized. KCRCF is required by the MDOC to forward all inmate grievances to MDOC for acceptance and review. MDOC will then provide response to KCRCF. The procedure for filing a grievance is located in the inmate handbook and the agency policy. There is no designated time limit in which a grievance can be filed regarding an allegation of sexual abuse, harassment or retaliation. KCRCF policy prohibits the grievance of sexual abuse to be submitted to or referred to the subject of the complaint.

115.53 Inmate access to outside confidential support services Auditor Overall Determination: Meets Standard **Auditor Discussion** The agency maintains a state wide agreement with rape crisis centers throughout the state to address emergent and crisis centered issues. All contacts are confidential. The facility provides the inmate population with access to outside victim advocates for emotional support services related to sexual abuse through the Mississippi Coalition Against Sexual Abuse by way of a Memorandum of Understanding with MDOC. Auditor observed the postings and confirmed knowledge of the information in the Inmate Random interviews. Auditor also contacted MCASA to confirm the requirements of the MOU. Mailing addresses and toll-free hotline numbers are provided to the inmate population. Outside and third-party reports can be sent to the advocate office and can be completely confidential. Information or requests can be received by mail or telephone. No identifying information is required for the office to act and become involved in an alleged incident or need or to provide direct service to the inmate. The PAQ indicates that there have been no reports, no requests for advocacy, and no incidents occurring at KCRCF in the past year. All inmates interviewed were knowledgeable about hotline and it is readily visible in all housing units. All phones in the housing areas were tested and proved to be working. The inmates can dial 6500 to report anonymously and this method was verified by auditor during onsite review. The inmates were not only knowledgeable that there was a reporting method in place but could also articulate the exact numbers to use in the event of an assault. Each time an inmate picks up the phone, the prompt provides the option to connect to report sexual assault.

In addition, the notification is also posted in the visitation area, readily available to all visitors for third party reporting options. All reports are taken seriously, regardless of the reporting method. Each allegation is investigated immediately upon receipt of the information. The MDOC information posted in all units indicates the ability and information needed to report this type of incident to MDOC central office staff as well.
