Section 1: General Conditions

ALL BIDS SUBMITTED SHALL BE IN COMPLIANCE WITH ALL CONDITIONS SET FORTH HEREIN. THE BID PROCEDURE FOLLOWED BY THIS OFFICE WILL BE IN ACCORDANCE WITH THESE CONDITIONS. THEREFORE, ALL BIDDERS ARE URGED TO READ AND UNDERSTAND THESE CONDITIONS PRIOR TO SUBMITTING A BID.

1.1 Definitions

Agency- for the purposes of this IFB, “Agency” shall be defined as the Mississippi Department of Corrections (MDOC).

Time of performance. The number of calendar days in which delivery will be made after receipt of order shall be indicated in the bid specification.

Bid Sample – A sample to be furnished by a bidder to show the characteristics of the item offered in the bid.

Descriptive Literature – Information available in the ordinary course of business which shows the characteristics of an item which enables the purchasing entity to consider whether the items meets its needs.

1.2 Preparation of Bids

- 1.2.1 Bids may be submitted through the State of Mississippi’s e-procurement system-MAGIC - <https://www.dfa.ms.gov/dfa-offices/mmrs/mississ>, United States Postal Service, delivery service or hand-delivered to the Mississippi Department of Corrections at the address listed above.
- 1.2.2 Paper bids are allowed. Bid must be typed or printed in ink. All prices and notations must be printed in ink or typed. No erasures permitted. Errors may be crossed out and corrections printed in ink or typewritten adjacent and must be initialed, in ink, by the person signing bid.
- 1.2.3 Deliveries of bids via United State Postal Services, delivery service or hand-delivered must indicate on the face of the envelope, in addition to the above address, the date and time of the bid opening and the bid number.
- 1.2.4 To submit bids electronically, bidders must ensure they are registered in the MAGIC system (MAGIC Vendor Information, <https://merlin.state.ms.us/merlin/predef.nsf/MAGICVendorInfo?OpenForm>) and have been received a login, password, and supplier number and that all technical requirements have been met.
- 1.2.5 If a bidder is unwilling or unable to participate through MAGIC, an MDOC representative can enter the Vendor’s bid(s) manually (i.e. Surrogate Bidding).
- 1.2.6 Failure to examine any specifications and instructions will be at bidder’s risk.
- 1.2.7 Price should be stated as “Per Inmate Per Day” (PIPD).

- 1.2.8 It is understood that reference to available specifications shall be sufficient to make the terms of such specifications binding on the bidder.
- 1.2.9 Bidders must furnish all information requested in the bid specifications. Further, when required, each bidder must submit for bid evaluation descriptive literature and specifications covering the product offered. Reference to literature submitted with a previous bid or on file with MDOC will not satisfy this provision.
- 1.2.10 Samples of items, when requested, must be furnished free of expense to MDOC. Any sample submitted will be returned only at bidder's expense.

1.3 Bid Submission

- 1.3.1 When submitting a bid electronically, the authorized signature may be typed or be an electronic signature. When submitting a bid via mail, delivery service or hand-deliver, the authorized signature must be a wet signature.
- 1.3.2 Bids and modifications or corrections received after the closing time specified will not be considered.
- 1.3.3 When submitting the response to the IFB in MAGIC, bidder must ensure all questions have been answered within the IFB and all proposed items in bid have a response.
- 1.3.4 Bidders submitting paper responses should submit responses to the MDOC by the response deadline.

1.4 Acceptance of Bids

MDOC reserves the right to reject any and all bids, to waive any informality in bids and unless otherwise specified by the bidders, to accept any items on the bid. The MDOC reserves the right to modify or cancel in whole or in part its Invitation for Bids (IFB). If a bidder fails to state the time within which a submitted bid will expire, it is understood and agreed that the MDOC shall have 60 days to accept.

1.5 Error in Bids

- 1.5.1 Bidders are expected to examine the specifications, delivery schedule, bid process, extensions and all instructions pertaining to food products and deliveries. Failure to do so will be at the bidder's risk.

1.6 Bid Opening

The bid opening shall be public, on the date and time specified in the Timeline herein. It is the bidder's responsibility to assure that the bid is delivered at the proper time and place of the bids.

1.7 Award

- 1.7.1 As the best interest of the State may require, the right is reserved to make award(s) based on the Price Per Inmate Per Day (PPID). When it is determined there is competition to the lowest responsible bidder, evaluation of other bids is not required. Bidders are cautioned to make no

assumptions unless their bid has been valuated as being responsive. All awards made as a result of this bid shall conform to applicable MS Statutes.

- 1.7.2 Contracts and purchases will be made or entered into with the lowest responsive and responsible bidder meeting specifications, except as otherwise specified in the bid specifications.
- 1.7.3 A written purchase order or contract award furnished to the successful bidder within the time of acceptance specified in the Invitation for Bid results in a binding contract without further action by either party. The contract shall consist solely of these General Conditions, the Instructions and Special Conditions, the successful bidder's bid, and the written purchase order or contract award. The contract shall not be assignable in whole or in part without written consent of the State.

1.8 Fixed Price Contract with Price Adjustment

- 1.8.1 Bid price shall include all packaging, handling, shipping charges and delivery to the destinations shown hereto.
- 1.8.2 Price accepted from bidder submissions shall be firm for the term of the contract except that the State shall receive the benefit of any price decrease in excess of five percent (5%). The contractor must provide written price reduction information within ten (10) days of its effective date.
- 1.8.3 MDOC may consider an increase in Food Product payment per day, if vendor can provide substantive evidence and documentation to grant and increase (PPI or CPI) in price per day. If granted, food increase in price per day, shall not exceed five percent (5%) of current year's price per day. It shall be the responsibility of the bidder to thoroughly familiarize themselves with the provisions of the specifications. No consideration will be given to any claim of misunderstanding after contract execution.
- 1.8.4 PPD shall be based on delivered to MDOC facility. No additional surcharges or fees will be allowed.

1.9 Discounts

Cash discounts for prompt payment shall not be considered in determining the lowest net cost for bid evaluation purposes.

1.10 Taxes

The MDOC is exempt from federal excise taxes, state and local taxes or use taxes. Bidders must quote prices which do not include such taxes. Exemption certificates will be furnished upon request. MDOC's tax exemption number is 64-74-0123-K.

1.11 Inspection

Inspection and acceptance will be destination unless otherwise provided. Title and risk of loss damage to all items shall be the responsibility of the supplier until accepted by the ordering agency, unless loss or damage results from negligence by the ordering agency. The contract supplier shall be responsible for filing, processing and collecting all damage claims. However, to assist the supplier in the expeditious handling of damage claims, the ordering agency will:

- (a) Report any evidence of visible damage on all copies of the delivering carrier's Bill of Lading.
- (b) Report damage, visible and concealed, to the carrier and contract supplier, confirming such reports, in writing within 5 days of delivery, requesting that the carrier inspect the damaged merchandise.
- (c) Retain the item and its shipping container, including inner packing material, until inspection is performed by the carrier, and disposition given by the contract supplier.
- (d) Provide contract supplier with a copy of the carrier's Bill of Lading and damage inspection report.

1.12 Conditions and Packaging

It is understood and agreed that any item(s) offered or shipped as a result of this bid shall meet all applicable federal, state and local regulations. All containers shall be suitable for storage and shipment, and all prices shall include standard commercial packaging.

1.13 Safety Standards

Unless otherwise stipulated in the bid, all food products must be handled and shipped in accordance with all applicable health and safety standards.

1.14 Invoicing and Payment

The contractor shall be paid upon submission of properly certified invoices to the purchaser at the prices stipulated in the contract at the time the order is placed, after delivery and acceptance of goods, less deductions if any as provided. Invoices shall contain the contract number and purchase order number. An original and one (1) copy of the invoice shall be submitted. Failure to follow these instructions may result in delay in processing invoice for payment.

1.15 Annual Appropriations

It shall be understood that any contracts entered into as a result of this bid that shall be in effect subsequent to June 30th of any calendar year is subject to the terms of the non-appropriation clause. This clause provides that any contract which extends past June 30th of any calendar year may be canceled for lack of funds. If this should become necessary, MDOC is not obligated to pay for any items which is not covered by a purchase order dated prior to June 30th.

1.16 Delivery

Unless actual date is specified (or specified delivery cannot be met), bidder must specify the number of days required to make delivery after receipt of purchase order. Delivery time may become a basis for making an award (see Special Conditions). Delivery shall be within the normal working hours of the facility, Monday through Friday unless otherwise specified.

1.17 Additional Terms and Conditions

No additional terms and conditions included with the bid response shall be evaluated or considered and any and all such additional terms and conditions shall have no force and effect and are inapplicable to this bid. If submitted either purposely through intent or design or inadvertently appearing separately in transmittal letters, specifications, literature, price lists or warranties, it is understood and agreed the general and special conditions in this bid solicitation are the only conditions applicable to this bid and the bidder's authorized signature affixed to the Bidder Acknowledgment form attests to this.

1.18 Manufacturers' Name and Approved Equivalents

- 1.18.1 Any manufacturers' name, trade names, information and/or catalog numbers listed in specification are for information and not intended to limit competition. The bidder may offer any brand for which it is an authorized representative, which meets or exceeds the specifications for any item(s).
- 1.18.2 Customary measurements appearing in these specifications are not intended to preclude bids for commodities with metric measurements. If bids are based on equivalent products, indicate on the bid form the manufacturer's name and number.
- 1.18.3 Bidder shall submit with its bid, a four-week menu cycle, complete with nutritional analysis and the corresponding order guide detailing the brand, pack and product specifications. Reference to literature submitted with a previous bid will not satisfy this provision.
- 1.18.4 The State of Mississippi reserves the right to determine acceptance of item(s) as an approved equivalent. Bids which do not comply with these requirements are subject to rejection. Bids lacking any written indication of intent to bid an alternate brand will be received and considered in compliance with the specifications as listed on the bid form. The purchaser is to be notified of any proposed changes. However, changes shall not be binding upon the State unless evidenced by a Change of Notice issued and signed by the State.

1.19 Interpretations/Disputes

Any questions concerning conditions and specifications shall be directed in writing to this office for receipt no later than five (5) days prior to the bid opening and must reference the date of bid opening and bid number.

1.20 Ambiguous Bids

Ambiguous bids which are uncertain as to terms, delivery, quantity, or compliance with specifications may be rejected or otherwise disregarded.

1.21 Nonconformance to Contract Conditions

- 1.21.1 Items may be tested for compliance with specifications. The data derived from any tests for compliance with specifications are public records and open to examination.
- 1.21.2 Items delivered not conforming to specifications will be rejected and returned at the bidder's expense. These items and items not delivered as per delivery date in bid and/or purchase order may result in bidder being found in default in which event any and all re-procurement costs may be charged against the defaulting contractor. Any violation of these stipulations will also result in: (a) Supplier's name being removed from the vendor mailing list. (b) The State Office of Purchasing and Travel shall be notified of such action taken.

1.22 Liability

The supplier shall hold and save the State of Mississippi, its officers, agents and employees harmless against claims by third parties resulting from the supplier's breach of this contract or the supplier's negligence.

1.23 Facilities

The State reserves the right to inspect the bidder's facilities at any reasonable time with prior notice.

1.24 Gifts, Rebate, Gratuities

1.24.1 Acceptance of gifts from bidders is prohibited. No officer or employee of the MDOC, nor any head of any state department, institution or agency, nor any employee of any state department, institution or agency charged with responsibility of initiating requisitions, shall accept or receive, directly or indirectly, from any person, firm or corporation to whom any contract for the purchase of materials, supplies, or equipment for the State of Mississippi may be awarded, by rebate, gifts, or otherwise, any money or anything of value whatsoever, or any promise, obligation or contract for future rewards or compensation.

1.24.2 Bidding by state employees is prohibited. It is unlawful for any state official or employee to bid on, or sell, or offer for sale, any merchandise equipment or material, or similar commodity to the State during the tenure of his or her office or employment, or for the period prescribed by law thereafter, or to have any interest in the selling of the same to the State.

1.25 Bid Information

Bid information and documents may be examined pursuant to the Mississippi Public Records Act of 1983, MS Code § 25-61-1 et seq.

1.26 Precedence

Bids shall be made and the contract shall be entered into in accordance with the General Conditions as hereinafter amended and modified. Should a conflict exist between the General Conditions and the Instructions and Special Conditions, the Instructions and Special Conditions shall take precedence.

1.27 Competition

There are no federal or state laws that prohibit bidders from submitting a bid lower than a price or bid given to the U.S. Government. Bidders may bid lower than U.S. Government contract price without any liability as the State is exempt from the provisions of the Robinson-Patman Act and other related laws. In addition, the U.S. Government has no provisions in any of its purchasing arrangements with bidders whereby a lower price to the State must automatically be given to the U.S. Government.

1.28 Waiver

MDOC reserves the right to waive any General Condition, Special Condition, or minor specification deviation when considered to be in the best interest of the State.

1.29 Cancellation

Any contract or item award may be canceled with or without cause by the State with the giving of 30 days written Notice of Intent to Cancel. Cause for the State to cancel may include, but is not

limited to, cost exceeding current market prices for comparable purchases; request for increase in prices during the period of the contract; or failure to perform to contract conditions. The Contractor will be required to honor all purchase orders that were prepared and dated prior to the date of expiration or cancellation if received by the Contractor within a period of thirty (30) days following the date of expiration or cancellation. Cancellation by the State does not relieve the Contractor of any liability arising out of a default or nonperformance. If a contract is canceled by the State due to a Contractor's request for increase in prices or failure to perform, that Contractor will be disqualified from bidding for a period of twenty-four (24) months.

1.30 Substitutions During Contract

During the term of a contract, if adequate documentation is provided that supports the claim that the contract item(s) are not available, items which meet the minimum specifications may be substituted if approved by MDOC Food Service Director and the substitutions are deemed to be in the best interest of the MDOC.

1.31 Application

1.31.1 It is understood and agreed by the bidder that any contract entered into as a result of this Invitation for Bids is established for use by state agencies and all purchases made by these agencies for products included under the provisions of the contract shall be purchased from the bidder receiving the award unless exempt by special authorization from the MDOC. Under the provisions of Section 31-7-7 Mississippi Code of 1972, Annotated.

1.31.2 Employees of the MDOC have acted exclusively as agents of the State for the award, consummation, and administration of the contract and are not liable for any performance or nonperformance by the state agencies that utilize the contract.

1.32 Addenda

1.32.1 Addenda modifying specifications may be issued if time permits. No addendum will be issued within a period of two (2) working days prior to the time and date set for the bid opening. Should it become necessary to issue an addendum within the two (2) day period prior to the bid opening, the bid date will be reset to a date not less than five (5) working days after the date of the addendum, giving bidders ample time to comply with the addendum.

1.32.2 When replying a bid request on which an addendum has been issued, and the specifications require acknowledgment, the bid shall indicate that provisions of the addendum have been noted and that the bid is being offered in compliance therewith. Failure to make this statement may result in the bid being rejected as not being in accordance with the revised specifications or plans.

1.33 Non-Responsive Bids

Non-responsive bids will not be considered. A non-responsive bid is considered to be a bid that does not comply with the minimum provisions of the specification. Any bidder found to repeatedly offer alternated products that are not compliant with specifications in an attempt to obtain a contract on the basis of pricing only will be disqualified from bidding for a period of twenty-four (24) months.

1.34 Specification Clarification

It shall be incumbent upon all bidders to understand the provisions of the specifications and to obtain clarification prior to the time and date set for the live auction or bid opening. Such clarification will be answered only in response to a written request submitted in the specified amount of time set by the MDOC. The MDOC reserves the right to specify a time frame in which clarification request shall be made.

1.36 Contract Extension

1.36.1 Automatic contract renewals or extensions are not allowed. Contract must be extended or renewed with the proper documents signed or approved by the MDOC.

1.37 Suspension and Debarment

By submitting a bid, the bidder is certifying that neither the bidder nor any potential subcontractors are debarred or suspended or are otherwise excluded from or ineligible for participation in federal assistance programs.

1.38 Assignment

The Contractor shall not assign or subcontract in whole or in part, its right or obligations under this agreement without prior written consent of the MDOC. Any purchase order issued pursuant to this invitation for bid and the monies which may become due hereunder are not assignable except with the prior written approval of the MDOC.

1.39 Indemnification

Contractor shall indemnify, defend, save and hold harmless, protect, and exonerate the State of Mississippi, its Commissioners, Board Members, officers, employees, agents, and representatives from and against all claims, demands, liabilities, suits, actions, damages, losses, and costs of every kind and nature whatsoever, including, without limitation, court costs, investigative fees and expenses, and attorneys' fees, arising out of or caused by Contractor's and/or its partners, principals, agents, employees, and/or subcontractors in the performance of or failure to perform this Agreement. In the State's sole discretion, Contractor may be allowed to control the defense of any such claim, suit, etc. In the event Contractor defends said claim, suit, etc., Contractor shall use legal counsel acceptable to the State; Contractor shall be solely liable for all reasonable costs and/or expenses associated with such defense and the State shall be entitled to participate in said defense. Contractor shall not settle any claim, suit, etc., without the State's concurrence, which the State shall not unreasonably withhold.

1.40 Force Majeure

If the MDOC is closed for any reason, including but not limited to: acts of God, strikes, lockouts, riots, acts of war, epidemics, governmental regulations superimposed after the fact, fire, earthquakes, floods, or other natural disasters (the "Force Majeure Events"), which closure prevents the opening of bids at the advertised date and time, all bids received shall be publicly opened and read aloud on the next business day that the agency shall be open and at the previously advertised time. The new date and time of the bid opening, as determined in accordance with this paragraph, shall not be advertised, and all bidders, upon submission of a bid proposal, shall be deemed to have knowledge of and shall have agreed to the provisions of this paragraph. Bids shall be received by the agency until the new date and time of the bid opening as set forth herein. The MDOC shall not be held responsible for the receipt of any bids for

which the delivery was attempted and failed due to the closure of the MDOC as a result of a Force Majeure Event. Each bidder shall be required to ensure the delivery and receipt of its bid by the MDOC prior to the new date and time of the live auction or bid opening.

1.42 Late Submissions

A bid received at the place designated in the solicitation for receipt of Bids after the exact time specified for receipt will **not** be considered.

Section 2: Instructions and Special Conditions

2.1 Purpose

The purpose of this Invitation for Bid (IFB) is to obtain bids from qualified and interested bidders to provide Food Products for Self-Operated Food Services. One contract will be awarded to one vendor to provide for Food Products at the following locations:

- a. Mississippi State Penitentiary (MSP);
- b. Marshall County Correctional Facility (MCCF);
- c. Walnut Grove Correctional Facility (WGCF);
- d. Central Mississippi Correctional Facility (CMCF) and Youth Offender Unit (YOU);
- e. Mississippi Correctional Institute for Women (MCIW);
- f. South Mississippi Correctional Institution (SMCI);
- g. Delta Correctional Facility (DCF);
- h. Eight (8) Community Work Centers (CWC) and three (3) Pre-Release (Restitution) Centers; and
- i. Any future facilities of MDOC.

The contract will be awarded to the lowest responsible and responsive bidder whose bid meets the requirements and criteria set forth in this IFB. The successful bidder will be responsible for the procurement and delivery of all food items to ensure that MDOC can prepare its Four-Week Cycle Menu (**Appendix B**) and Holiday Menus (**Appendix C**). The menu items will be prepared by MDOC staff and inmates in accordance to the recipes provided by the successful bidder's menu service.

2.2 Delivery Specifications

- 2.2.1 Weekly deliveries **must** be made to all MDOC facilities. (See **Appendix D** for Facility, Capacity and Physical Location). Deliveries must be made Monday through Friday between the hours of 8:00 a.m. and 3:00 p.m. CST.
- 2.2.2 The successful bidder will be required to have ample inventory on hand at all times to supply each facility with the required amount of food products to prepare and serve the designated menu at each facility for the total inmate populations plus thirteen percent (13%).
- 2.2.3 All frozen items must be delivered at a temperature of zero degrees Fahrenheit (0°) or below. Any refrigerated items must be delivered at a temperature between 35°- 40° Fahrenheit.
- 2.2.4 In case of a shortage, a like for like substitution can be made with prior approval by the MDOC Food Services Director.
- 2.2.6 All delivery drivers must have NCIC Background Check and be cleared before entering any MDOC facility. Drivers may not bring onto the grounds of any correctional institution items considered contraband. These items include but are not limited to: firearms, sharpened instruments or knives, other objects capable of inflicting harm/death, tools, explosives/ammunition, medication (prescribed/over-the-counter), illegal drugs, electronic devices or parts, escape paraphernalia, staff clothing or uniform related items, tobacco products, cell phones except for driver's personal cell phone, cameras or any other items as mandated by Miss. Code Ann. § 47-5-193 (1972, as amended).

- 2.2.7 All delivery drivers are expected to maintain minimal physical and verbal contact with inmates and staff at the facilities.

2.3 Food and Meal Specifications

- 2.3.1 The food specification for the food product is located in Appendix A. These specifications shall be followed with no deviations or substitutions allowed unless prior approval is obtained from the MDOC Food Services Director with at least thirty (30) days advance notice.
- 2.3.2 Bids must be priced on Per Inmate, Per Day (PIPD) following the exact menu for each day based on three (3) meals per day per inmate.
- 2.3.3 In the event of an emergency involving bidder such as food production plants, manufacturers, and/or distributors, bidder must have the ability to provide uninterrupted food product deliveries. Bidder shall include emergency plan for food product deliveries with Bid. In the event of an emergency at MDOC facilities, MDOC will notify the vendor of the alternate delivery site. Bidder must acknowledge that all food products will meet or exceed the specifications listed in Appendix A. Emergency is defined, but not limited to, natural or man-made disaster, utility outage (power, gas, or water), pandemic, or other event(s).
- 2.3.4 USDA Commodities and Food Produced by MDOC. The MDOC qualifies to receive surplus commodities from the United States Department of Agriculture (USDA). There is no guarantee of the type or quantity of commodities that will be available.
- 2.3.4.1 The successful bidder agrees to maximize the utilization of any food items obtained through the commodities program of the USDA or any other similar food source, which will be credited against the weekly invoice at a value determined by the USDA.
- 2.3.4.2 The MDOC will be producing vegetables in their farm operations. Vegetables grown/produced by the MDOC will be utilized and processed by the MDOC and will have priority over purchased items. These items will be credited against the weekly invoice. This value will be declared by MDOC and adjusted for processing based on the USDA National FOB Review (**Appendix E**).

2.6 Market Information

- 2.6.1 The MDOC expects the selected bidder to provide the MDOC Food Service Director with market information related to product condition and quality, pricing trends and new products, and if appropriate, the bidder shall make recommendations on more appropriate product(s) to use.
- 2.6.2 Substitutions and Shortages. All substitutions must be approved by the MDOC Food Service Director or designee. Substitutions must be equal to or better than the contracted items.

2.7 Menu Cycle

- 2.7.1 MDOC will run a four-week menu cycle starting with week one. After the fourth week, the menu will start over again with week one. Every six months the menu may be changed to substitute different meals. Changes will be made only after a menu conference is held with the MDOC

Food Services Director and the selected bidder. This will allow MDOC to change products that are not being accepted well by offenders. MDOC will place orders with the bidder one week in advance of each week. This will allow time to make any necessary menu changes.

2.8 Other Conditions

- 2.8.1 Invoicing. The successful bidder shall invoice MDOC at the corresponding cost per inmate, per day on a weekly basis based on the daily midnight count provided by the inmate locator offices. The billing cycle will be Saturday through Friday. The weekly invoice will contain the total population for the week, the corresponding price and the total for each facility. A detailed report showing the count by day for each facility will be provided as backup for the invoice.
- 2.8.2 Term of Contract. The contract shall be for three (3) years beginning March 1, 2026 and ending February 28, 2029. Upon written agreement of both parties at least ninety (90) days prior to the contract anniversary date, the contract may be renewed by the MDOC for a period of one (1) successive one-year period. The total number of renewal years permitted shall not exceed two (2). Total contract term may not exceed sixty (60) months or five (5) years.
- 2.8.3 Price Adjustment. The bidder must guarantee the prices for the twelve months of the contract. MDOC will conduct a Vendor Review annually in April to discuss food quality, vendor performance, and cost of food. MDOC may consider an increase in Food Product payment per day, if vendor can provide substantive evidence and documentation to grant and increase (PPI or CPI) Food increase in price per day, if granted, may not exceed five percent (5%) of current year's price per day. It shall be the responsibility of the bidder to thoroughly familiarize themselves with the provisions of these specifications. After executing the contract, no consideration will be given to any claim of misunderstanding.

The bidder agrees to abide by the rules and regulations as prescribed herein and as prescribed by the MDOC as the same now existing, or may exist hereafter from time-to-time be changed in writing.

2.8.4 Insurance.

- 2.8.4.1 The proposed bidder is required to provide to MDOC with proof of insurance to include, but not limited to the following:
- a. **Workers' Compensation and Employers' Liability Insurance** to cover obligations imposed by Federal and State Statutes having jurisdiction of its employees engaged in the performance of the services, and Employers' Liability insurance with a minimum limit of one hundred thousand dollars (\$100,000.00). Evidence of self-insured status shall also suffice for this section.
 - b. **Comprehensive General Liability** coverage for bodily injury, death, and property damage, including personal injury liability, products and completed operations.
 - **Property Damage:** Minimum One million dollars (\$1,000,000.00) per occurrence limit for any single claimant; and two million dollars (\$2,000,000.00) per occurrence for multiple claimants.
 - c. **Contractual Liability/Bodily Injury** with a minimum coverage amount of one million dollars (\$1,000,000.00).

- d. **Motor Vehicle Liability Insurance** cover all vehicles, owned or otherwise, used in this contract with limits of at least one million dollars (\$1,000,000.00) per occurrence for any single claimant; and two million dollars (\$2,000,000.00) per occurrence limit for multiple claimants.
- e. **Fidelity Bond Insurance on Contractor's Employees** with a minimum coverage of fifty thousand dollars (\$50,000.00).

2.8.4.2 Insurance carriers must be licensed or hold Certificate of Authority from the Mississippi Department of Insurance and such certificate shall identify the Contract and contain provisions that coverage afforded under the policies shall not be canceled, terminated or materially altered. **There are no provisions for exceptions to this requirement. Failure to provide the certificates of insurance may be cause for the bid to be disqualified or for the contract to be cancelled.**

2.8.5 Performance Bond. The successful bidder is required to establish and furnish, to the MDOC within 30 days of the published Contract Intent to Award, a performance bond in the amount \$1,000,000.00. Said performance bond shall be in the form of bond issued by an insurance company in the State of Mississippi and countersigned by an agent resident in Mississippi. The performance bond shall be in force for the life of the contract. **There are no exceptions to this requirement. Failure to provide the performance bond certificate may be cause for the contract to be cancelled.**

2.9 Bidder's Responsibilities

Minimum requirements for the successful bidder to be deemed responsible include the following:

- 2.9.1 Bidder must demonstrate the ability to provide and deliver food products to facilities as designated herein. Bidder must submit a listing of past and present institutional consumers along with contract information.
- 2.9.2 Bidder must provide two (2) years of certified financial statements with notes reflecting a capability to sustain operations.
- 2.9.3 Bidder must acknowledge full accountability and responsibility for all food product deliveries.
- 2.9.4 Bidder must acknowledge compliance with all federal, state, and local laws pertaining to food product delivery.
- 2.9.5 Bidder must submit an emergency plan for contingent deliveries.
- 2.9.6 Bidder is to provide an operating transition plan that will include risks and contingencies, strategies, transition schedule, transition resources, reporting and communication procedures, and transition team. The purpose of transition planning is to layout the tasks and activities that need to take place to effectively deliver food products requested in this IFB to ensure that the bidder can provide food products without interruption.
- 2.9.7 Bidder must provide a schedule of the proposed delivery system, reflecting time requirements for delivery to all facilities listed in this IFB.

- 2.9.8 Bidder must provide information on bidder's automated inventory management system on all food products provided to MDOC, if available, and MDOC's ability to utilize this system.
- 2.9.9 Bidder must establish or have in place, if awarded, the contract, a regional office in the State of Mississippi which must be maintained throughout the term of the contract. The office cannot be located at any of the MDOC facilities.
- 2.9.10 Bidder must provide MDOC with an acceptable nutritional menu program with recipe capabilities, as well as a Mississippi licensed Registered Dietician Nutritionist.

2.10 Quality Assurance

- 2.10.1 Bidder must be able to provide samples, at the cost of the bidder, for testing to ascertain the most acceptable/appropriate products to MDOC needs.
- 2.10.2 Bidder's must provide the MDOC Food Service Director or designee copies of the bidder's product specifications for review within 48 hours of request.
- 2.10.3 The successful bidder acknowledges that MDOC reserves the right to request product quality testing during any period of the contract term. Product quality testing may take place at any facility listed within this IFB. At the beginning of the contract, the MDOC anticipates the need for a large amount of can cutting and product testing to decide the quality level of the items to purchase. A select number of MDOC personnel will attend these testing sessions. Throughout the contract, additional testing will be performed at the request of the MDOC Food Service Director or designee.

Section 3: Bid Evaluation and Award

3.1 Bid Evaluation

- 3.1.1 Bids will be evaluated based on lowest per inmate per day price and the requirements and specifications set forth herein, which may include criteria to determine acceptability such as inspection, testing, quality, delivery, nutritional menu program, and suitability for a particular purpose. These criteria along with the price per inmate per day price will be considered in evaluation for award and shall be objectively measurable where possible. This Invitation for Bids sets forth the evaluation criterion to be used. No criteria will be used in this evaluation that is not set forth in this Invitation for Bids. Only Bidders who are found responsive and responsible will have their Bids considered.
- 3.1.2 MDOC will evaluate bids based on the requirements set forth in this IFB. No criteria will be used in an evaluation that is not outlined in this Invitation for Bids.

3.2 Nonconforming Terms and Conditions

A bid response that includes terms and conditions that do not conform to the terms and conditions in the IFB is subject to rejection as non-responsive. MDOC reserves the right to permit the Bidder to withdraw nonconforming terms and conditions from its bid response prior to a determination by MDOC of non-responsiveness based on the submission of nonconforming terms and conditions. This reservation of rights shall not be interpreted as a requirement that MDO permit withdrawal of nonconforming terms and conditions.

3.2 Minimum Requirements to Be Deemed Responsive

- 3.2.1 Bidder must submit a bid which conforms in all material respects to the IFB as determined by MDOC.
- 3.2.2 In order to be deemed responsive the Bidder must:
- a. Completed Bid Cover Sheet (**Attachment A**)
 - b. Completed Bid Form (**Attachment B**)
 - c. Signed Certifications and Assurances (**Attachment D**)

3.3 Minimum Requirements to Be Deemed Responsible

A bidder must meet each of the following minimum qualifications to be deemed responsible:

These references must be familiar with the Bidder's abilities in the areas involved with this solicitation. The MDOC will use these references to determine the Bidder's ability to perform the services. - 3.3.3 Bidder must demonstrate the ability to provide and deliver food products to facilities in similar scale and size as designated herein. Bidder must submit a listing of past and present institutional consumers along with contract information.
- 3.3.4 Bidder must provide two (2) years of certified financial statements with notes reflecting a capability to sustain operations.
- 3.3.5 Bidder must acknowledge full accountability and responsibility for all food product deliveries.
- 3.3.6 Bidder must acknowledge compliance with all federal, state, and local laws pertaining to food product delivery.
- 3.3.7 Bidder must submit an emergency plan for contingent deliveries.
- 3.3.8 Bidder is to provide an operating transition plan that will include risks and contingencies, strategies, transition schedule, transition resources, reporting and communication procedures, and transition team. The purpose of transition planning is to layout the tasks and activities that need to take place to effectively deliver food products requested in this IFB to ensure that the bidder can provide food products without interruption.
- 3.3.9 Bidder must provide a schedule of the proposed delivery system, reflecting time requirements for delivery to all facilities listed in this IFB.
- 3.3.10 Bidder must provide information on bidder's automated inventory management system on all food products provided to MDOC, if available, and MDOC's ability to utilize this system.
- 3.3.11 Bidder must establish or have in place, if awarded, the contract, a regional office in the State of Mississippi which must be maintained throughout the term of the contract. The office cannot be located at any of the MDOC facilities.
- 3.3.12 Bidder must provide MDOC with an acceptable nutritional menu program with recipe capabilities, as well as a Mississippi licensed Registered Dietician Nutritionist.

3.4 Award Notification

All participating bidder will be notified of the MDOC's intent to award a contract in writing. The Notice of Intent to Award is also made available to the public.

3.5 Protest of Award

- 3.5.1 Any actual or prospective Bidder or contractor who is aggrieved in connection with this solicitation or the outcome of the Invitation for Bids may file a protest with **Burl Cain, Commissioner and Courtney E. Cockrell, Deputy General Counsel**. The protest shall be submitted in writing within seven (7) days after such aggrieved person knows or should have known of the fact giving raised hereto.
- 3.5.2 All protests must be in writing, dated, signed by the Bidder or an individual authorized to sign contracts on behalf of the protesting Bidder, and contain a statement of the reason(s) for protest, citing the law(s), rule(s) or regulation(s), and/or procedure(s) on which the protest is based. The written protest letter shall contain the name and address of the Protestor, the RFX number and name, and explanation of the specific basis for the protest. The protesting Bidder must provide facts and evidence to support the protest.
- 3.5.3 A protest is considered filed when received by **Courtney E. Cockrell**, via either U.S. mail, postage prepaid, or personal delivery.

3.6 Protest Notice of Decision

A copy of the Notice of Decision shall be mailed or otherwise furnished immediately to the protestant and any other party intervening.

3.7 Finality of Decision

A decision shall be final and conclusive, unless fraudulent, or: Any person adversely affected by the decision appeals administratively to the Procurement Review Board in accordance with Section 6.204.

- 1. APPLICABLE LAW:** The contract shall be governed by and construed in accordance with the laws of the State of Mississippi, excluding its conflicts of laws provisions, and any litigation with respect thereto shall be brought in the courts of Mississippi.
- 2. APPROVAL:** It is understood that if this contract requires approval by the Public Procurement Review Board (“PPRB”) and/or the Department of Finance and Administration Office of Personal Service Contract Review (“OPSCR”), and this contract is not approved by PPRB and/or OPSCR, it is void and no payment shall be made hereunder.
- 3. AVAILABILITY OF FUNDS:** It is expressly understood and agreed that the obligation of MDOC to proceed under this agreement is conditioned upon the appropriation of funds by the Mississippi State Legislature and the receipt the appropriated funds. If the funds anticipated for the continuing time fulfillment of the agreement are, at any time, not forthcoming or insufficient, regardless of the source of funding, MDOC shall have the right upon 10 business days written notice to Contractor, to terminate this agreement without damage, penalty, cost or expense to the MDOC of any kind whatsoever. The effective date of termination shall be as specified in the notice of termination.
- 4. All general liability and professional liability will provide coverage to the MDOC as an additional insured. The MDOC reserves the right to request from carriers, certificates of insurance regarding the required coverage. Insurance carriers shall be licensed or hold a Certificate of Authority from the Mississippi Department of Insurance.

10. **NO LIMITATION OF LIABILITY:** Nothing in this agreement shall be interpreted as excluding or limiting any liability of the Contractor for harm arising out of the Contractor's or its subcontractors' performance under this agreement.
11. **PAYMODE:** Payments by MDOC using the state's accounting system shall be made and remittance information provided electronically as directed by the state and deposited into the bank account of Contractor's choice. REPRESENTATION REGARDING GRATUITIES:** Contractor represents that it has not, is not, and will not offer, give, or agree to give any employee or former employee of MDOC a gratuity or offer of employment in connection with any approval, disapproval, recommendation, development, or any other action or decision related to the solicitation and resulting contract. Contractor further represents that no employee or former employee of MDOC has or is soliciting, demanding, accepting, or agreeing to accept a gratuity or offer of employment for the reasons previously stated; any such action by an employee or former employee in the future, if any, will be rejected by contractor. Contractor further represents that it is in compliance with the Mississippi Ethics in Government laws, codified at Mississippi Code Annotated §§ 25-4-101 through 25-4-121, and has not solicited any employee or former employee to act in violation of said law.
- 15. REQUIRED PUBLIC RECORDS AND TRANSPARENCY:** Upon execution of a contract, the provisions of the contract which contain the personal or professional services provided, the unit prices, the overall price to be paid, and the term of the contract shall not be deemed to be a trade secret or confidential commercial or financial information pursuant to Mississippi Code Annotated § 25-61-9(7). The contract shall be posted publicly on www.transparency.ms.gov and shall be available for at the Agency for examination, inspection, or reproduction by the public. The contractor acknowledges and agrees that the MDOC and this contract are subject to the *Mississippi Public Records Act of 1983* codified at Mississippi Code Annotated §§ 25-61-1, *et seq.* and its exceptions, Mississippi Code Annotated § 79-23-1, and the *Mississippi Accountability and Transparency Act of 2008*, codified at Mississippi Code Annotated §§ 27-104-151, *et seq.*
- 16. STOP WORK ORDER:** The MDOC may, by written order to Contractor at any time, require Contractor to stop all or any part of the work called for by this contract. This order shall be for a period of time specified by the MDOC. Upon receipt of such an order, Contractor shall forthwith comply with its terms and take all reasonable steps to minimize any further cost to the MDOC. Upon expiration of the stop work order, Contractor shall resume providing the services which were subject to the stop work order, unless the MDOC has terminated that part of the agreement or terminated the agreement in its entirety. The MDOC is not liable for payment for services which were not rendered due to the stop work order.
- 17. TERMINATION:** *Termination for Convenience.* The MDOC may, when the interests of the Agency so require, terminate this contract in whole or in part, for the convenience of the Agency. The MDOC shall give written notice of the termination to Contractor specifying the part of the contract terminated and when termination becomes effective. Contractor shall incur no further obligations in connection with the terminated work and on the date set in the notice of termination Contractor will stop work to the extent specified. Contractor shall complete the work not terminated by the notice of termination and may incur obligations as are necessary to do so.

Termination for Default. If the MDOC gives the Contractor a notice that the personal or professional services are being provided in a manner that is deficient, the Contractor shall have 30 days to cure the deficiency. If the Contractor fails to cure the deficiency, the MDOC may terminate the contract for default and the Contractor will be liable for the additional cost to the MDOC to procure the personal and professional services from

another source. Termination under this paragraph could result in Contractor being excluded from future contract awards pursuant to Chapter 15 of the *Public Procurement Review Board Office of Personal Service Contract Review Rules and Regulations*. Any termination wrongly labelled termination for default shall be deemed a termination for convenience.

Attachment F: Optional Clauses for Use in Service Contracts Resulting from This IFB

- 1. Attorney's Fees and Expenses.** In the event Contractor defaults on any obligations under this Agreement, Contractor shall pay to MDOC all costs and expenses, without limitation, incurred by MDOC in enforcing this Agreement or reasonably related to enforcing this Agreement. This includes but is not limited to investigative fees, court costs, and attorneys' fees. Under no circumstances shall MDOC be obligated to pay attorneys' fees or legal costs to Contractor.
- 2. Authority of Signatory.** Contractor acknowledges that the individual executing the contract on behalf of the MDOC is doing so in his or her official capacity only. To the extent any provision contained in the contract exceeds the signatory's authority, Contractor agrees that it will not look to that individual in his or her personal capacity or otherwise seek to hold him or her individually liable for exceeding such authority.
- 3. Authority to Contract.** Contractor warrants: (1) that it is a validly organized business with valid authority to enter into this agreement; (2) that it is qualified to do business and in good standing in the State of Mississippi; (3) that entry into and performance under this agreement is not restricted or prohibited by any loan, security, financing, contractual, or other agreement of any kind; and, (4) notwithstanding any other provision of this agreement to the contrary, that there are no existing legal proceedings or prospective legal proceedings, either voluntary or otherwise, which may adversely affect its ability to perform its obligations under this agreement.
- 4. Confidentiality.** MDOC is a public agency of the State of Mississippi and is subject to the *Mississippi Public Records Act of 1983*. Mississippi Code Annotated §§ 25-61-1, et seq. If a public records request is made for any information provided to MDOC by Contractor, MDOC shall follow the provisions of Mississippi Code Annotated §§ 25-61-9 and 79-23-1 before disclosing such information – unless Contractor has previously indicated the information is not a trade secret or confidential commercial and financial information. The MDOC shall not be liable to the Contractor for disclosure of information required by court order or required by law.
- 5. Contract Assignment and Subcontracting.** Contractor acknowledges that it was selected by MDOC to perform the services required hereunder based, in part, upon Contractor's special skills and expertise. Contractor shall not assign, subcontract, or otherwise transfer this agreement, in whole or in part, without the prior written consent of MDOC, which may, in its sole discretion, approve or deny without reason. Any attempted assignment or transfer of Contractor's obligations hereunder without consent of the MDOC shall be null and void. Approval of a subcontract by the MDOC shall not be deemed to be approval of the incurrence of any additional obligation of the MDOC. Subcontracts shall be subject to the terms and conditions of this agreement and to any conditions of approval that MDOC may deem necessary. Subject to the foregoing, this agreement shall be binding upon the respective successors and assigns of the parties.
- 6. Contractor Personnel.** The MDOC shall, throughout the life of the contract, have the right of reasonable rejection and approval of staff or subcontractors assigned to the work by Contractor. If the MDOC reasonably rejects staff or subcontractors, Contractor shall provide replacement staff or subcontractors satisfactory to the MDOC in a timely manner and at no additional cost to the MDOC. The day-to-day supervision and control of Contractor's employees and subcontractors is the sole responsibility of Contractor.
- 7. Copyrights.** Contractor agrees that the rights and title to any copyrightable material first produced under this agreement belongs to MDOC. Contractor hereby grants to MDOC a royalty-free, nonexclusive, irrevocable license to reproduce, translate, publish, use and dispose of, and to authorize others to do so, all copyrighted or copyrightable work which is incorporated in the material furnished under the agreement regardless of whether it was first produced under this agreement. This grant is provided that such license shall be only to

the extent Contractor now has, or prior to the completion of full final settlements of agreement may acquire, the right to grant such license without becoming liable to pay compensation to others.

- 8. Disclosure of Confidential Information Required by Law.** In the event that either party to this Agreement receives notice that a third-party has served upon it a subpoena or other validly issued administrative or judicial process ordering divulgence of the other party's data or other information, the party subject to the subpoena or other legal process shall promptly inform the other party at the earliest reasonable opportunity, unless prohibited by law from doing so. Thereafter, the party subject to the legal process shall respond to the extent mandated by law. This section shall survive the termination or completion of this agreement. The parties agree that this section is subject to and superseded by Mississippi Code Annotated §§ 25-61-1, *et seq.*
- 9. Entire Agreement.** This agreement, including all contract documents, represents the entire and integrated agreement between the parties hereto and supersedes all prior negotiations, representations or agreements, irrespective of whether written or oral. This agreement may be altered, amended, or modified only by a written document executed by the MDOC and Contractor. Contractor acknowledges that it has thoroughly read all contract documents and has had the opportunity to receive competent advice and counsel necessary for it to form a full and complete understanding of all rights and obligations herein. Accordingly, this agreement shall not be construed or interpreted in favor of or against the MDOC or Contractor on the basis of draftsmanship or preparation hereof.
- 10. Failure to Deliver.** In the event of failure of Contractor to deliver services in accordance with the contract terms and conditions, the MDOC, after due oral or written notice, may procure the services from other sources and hold Contractor responsible for any resulting additional purchase and administrative costs. This remedy shall be in addition to any other remedies that the MDOC may have.
- 11. Failure to Enforce Does Not Constitute Waiver.** Failure by the MDOC at any time to enforce the provisions of the contract shall not be construed as a waiver of any such provisions. Such failure to enforce shall not affect the validity of the contract or any part thereof or the right of the MDOC to enforce any provision at any time in accordance with its terms.
- 12. Force Majeure.** Each party shall be temporarily excused from performance for any period and to the extent that it is prevented from performing any obligation or service, in whole or in part, as a result of causes beyond the reasonable control and without the fault or negligence of such party and/or its subcontractors. Such acts shall include without limitation acts of God, strikes, lockouts, riots, acts of war, epidemics, governmental regulations superimposed after the fact, fire, earthquakes, floods, or other natural disasters ("force majeure events"). When such a cause arises, Contractor shall notify the Agency in writing at its earliest reasonable opportunity of the cause of its inability to perform, how it affects its performance, and the anticipated duration of the inability to perform. All parties shall make reasonable efforts to minimize the impact of the force majeure event on contract performance. The MDOC may exercise any rights it has under the contract which are available when neither party is in default.
- 13. Indemnification.** To the fullest extent allowed by law, Contractor shall indemnify, defend, save and hold harmless, protect, and exonerate the MDOC its commissioners, board members, officers, employees, agents, and representatives, and the State of Mississippi from and against all claims, demands, liabilities, suits, actions, damages, losses, and costs of every kind and nature whatsoever including, without limitation, court costs, investigative fees and expenses, and attorneys' fees, arising out of or caused by Contractor and/or its partners, principals, agents, employees and/or subcontractors in the performance of or failure to perform this agreement.

In the MDOC's sole discretion, upon approval of the Office of the Mississippi Attorney General and the MDOC, Contractor may be allowed to control the defense of any such claim, suit, etc. In the event Contractor defends said claim, suit, etc., Contractor shall use legal counsel acceptable to the Office of the Mississippi Attorney General and the MDOC. Contractor shall be solely responsible for all costs and/or expenses associated with such defense, and the MDOC shall be entitled to participate in said defense. Contractor shall not settle any claim, suit, etc. without the concurrence of the Office of the Mississippi Attorney General and the MDOC, which shall not be unreasonably withheld.

14. Independent Contractor Status. Contractor shall, at all times, be regarded as and shall be legally considered an independent contractor and shall at no time act as an agent for the MDOC. Nothing contained herein shall be deemed or construed by the MDOC, Contractor, or any third party as creating the relationship of principal and agent, master and servant, partners, joint ventures, employer and employee, or any similar such relationship between the MDOC and Contractor. Neither the method of computation of fees or other charges, nor any other provision contained herein, nor any acts of the MDOC or Contractor hereunder creates or shall be deemed to create a relationship other than the independent relationship of the MDOC and Contractor.

Contractor's personnel shall not be deemed in any way, directly or indirectly, expressly or by implication, to be employees of the MDOC. Neither Contractor nor its employees shall, under any circumstances, be considered servants, agents, or employees of the MDOC, and the MDOC shall be at no time legally responsible for any negligence or other wrongdoing by Contractor, its servants, agents, or employees.

The MDOC shall not withhold from the contract payments to Contractor any federal or state unemployment taxes, federal or state income taxes, Social Security tax, or any other amounts for benefits to Contractor. Further, the MDOC shall not provide to Contractor any insurance coverage or other benefits, including Workers' Compensation, normally provided by the MDOC for its employees.

15. Information Designated by Agency as Confidential. Any liability resulting from the wrongful disclosure of confidential information on the part of Contractor, or its subcontractor(s) shall rest with Contractor. Disclosure of any confidential information by Contractor or its subcontractor(s) without the express written approval of the MDOC may result in the immediate termination of this agreement.

16. Information Designated by Contractor as Confidential. Any disclosure of those materials, documents, data, and other information which Contractor has designated in writing as proprietary and confidential shall be subject to the provisions of Mississippi Code Annotated §§ 25-61-9 and 79-23-1. The services to be provided, the unit prices and overall price to be paid, and the term of the contract shall not be deemed a trade secret or confidential commercial or financial information.

17. Infringement Indemnification. Contractor warrants that the materials and deliverables provided to the MDOC under this agreement, and their use by the MDOC, will not infringe or constitute an infringement of any copyright, patent, trademark, or other proprietary right. Should any such items become the subject of an infringement claim or suit, Contractor shall defend the infringement action and/or obtain for the MDOC the right to continue using such items without additional cost to the Agency. Should Contractor fail to obtain for the MDOC the right to use such items, Contractor shall suitably modify them to make them non-infringing or substitute equivalent software or other items at Contractor's expense.

In the event the above remedial measures cannot possibly be accomplished, and only in that event, Contractor may require the MDOC to discontinue using such items, in which case Contractor will refund to the MDOC the fees previously paid by the MDOC for the items the customer may no longer use, and shall compensate the MDOC for the lost value of the infringing part to the phase in which it was used, up to and including the

contract price for said phase. Said refund shall be paid within 10 business days of notice to the MDOC to discontinue said use.

Scope of Indemnification: Provided that the MDOC promptly notifies Contractor in writing of any alleged infringement claim of which it has knowledge, Contractor shall defend, indemnify, and hold harmless the MDOC against any such claims, including but not limited to any expenses, costs, damages and attorney fees that a court finally awards for infringement based on the programs and deliverables provided under this agreement.

In the MDOC's sole discretion, upon approval of the Office of the Mississippi Attorney General and the MDOC, Contractor may be allowed to control the defense of any such claim, suit, etc. In the event Contractor defends said claim, suit, etc., Contractor shall use legal counsel acceptable to the Office of the Mississippi Attorney General and the MDOC. Contractor shall be solely responsible for all costs and/or expenses associated with such defense, and the MDOC shall be entitled to participate in said defense. Contractor shall not settle any claim, suit, etc. without the concurrence of the Office of the Mississippi Attorney General and the MDOC, which shall not be unreasonably withheld.

18. Liquidated Damages. By executing a Contract that results from this IFB, the Contractor expressly agrees to the imposition of liquidated damages. The Contractor hereby acknowledges and agrees that its performance under the Contract shall meet the requirement set forth in this IFB. If the Contractor fails to meet any item, service, deliverable or other duty of this IFB, the MDOC will impose Liquidated Damages of (\$250.00) per calendar day from date set for cure until either the State reasonably obtains similar services, if Contractor is terminated for default, or until Contractor provides the services if Contractor is not terminated for default. Any assessment of liquidated damages shall be accompanied by details sufficient for justification of the assessment. The MDOC shall deduct the liquidated damages from the next monthly invoice following the imposed damages. Documentation of the amount of damages imposed shall be included with the invoice.

19. Modification or Renegotiation Required by Change in Law. The parties agree to renegotiate the agreement in good faith if federal and/or state revisions to any applicable laws or regulations make changes in this agreement necessary. This agreement may be modified only by written agreement signed by the parties hereto and approval by the Public Procurement Review Board, if required.

20. Non-Solicitation of Employees. Each party to this agreement agrees not to employ or to solicit for employment, directly or indirectly, any persons in the full-time or part-time employment of the other party until at least one year after this agreement terminates unless mutually agreed to in writing by the MDOC and Contractor. Any such employment or solicitation for employment shall be in compliance with the Mississippi Ethics in Government laws, codified at Mississippi Code Annotated §§ 25-4-101 through 25-4-121.

21. Notices. All notices required or permitted to be given under this agreement shall be in writing and personally delivered or sent by certified United States mail, postage prepaid, return receipt requested, to the party to whom the notice should be given at the address set forth below. Notice shall be deemed given when actually received or when refused. The parties agree to promptly notify each other in writing of any change of address.

- 22. Oral Statements.** No oral statement of any person shall modify or otherwise affect the terms, conditions, or specifications stated in this contract. All modifications to the contract shall be made in writing by the MDOC, agreed to by Contractor, and approved by the Public Procurement Review Board, if required.
- 23. Ownership of Documents and Work Papers.** MDOC shall own all documents, files, reports, work papers and working documentation, electronic or otherwise, created in connection with the project which is the subject of this agreement, except for Contractor's internal administrative and quality assurance files and internal project correspondence. Contractor shall deliver such documents and work papers to MDOC upon termination or completion of the agreement. The foregoing notwithstanding, Contractor shall be entitled to retain a set of such work papers for its files and shall obtain written permission from MDOC to use such workpapers, subject to any copyright protections.
- 24. Priority.** The contract consists of this agreement, the IFB (RFx No. 3160007435), attached hereto as Attachment A, and the Contractor's bid submitted in response, attached hereto as Attachment B. Any ambiguities, conflicts, or questions of interpretation of this contract shall be resolved first by reference to this agreement and, if still unresolved, by reference to the IFB and, if still unresolved, by reference to the bid. Omission of any term or obligation from this agreement shall not be deemed an omission from this contract if such term or obligation is provided for elsewhere in this contract.
- 25. Quality Control.** Contractor shall institute and maintain throughout the contract period a properly documented quality control program designed to ensure that the services are provided at all times and in all respects in accordance with the contract. The program shall include providing supervision and conducting frequent inspections of Contractor's staff and ensuring that accurate records are maintained describing the disposition of all complaints. The records so created shall be open to inspection by the MDOC.
- 26. Record Retention and Access to Records.** Contractor shall maintain such financial records and other records as may be prescribed by the MDOC or by applicable federal and state laws, rules, and regulations. Provided Contractor is given reasonable advance written notice and such inspection is made during normal business hours of Contractor, the MDOC or any duly authorized representatives shall have unimpeded, prompt access to any of Contractor's books, documents, papers, and/or records which are relevant to this agreement. All records related to this agreement shall be retained by Contractor for three years after final payment is made under this agreement and all pending matters are closed; however, if any audit, litigation or other action arising out of or related in any way to this project is commenced before the end of the three year period, the records shall be retained for one year after all issues arising out of the action are finally resolved or until the end of the three year period, whichever is later.
- 27. Recovery of Money.** Whenever, under the contract, any sum of money shall be recoverable from or payable by Contractor to the MDOC, the same amount may be deducted from any sum due to Contractor under the contract or under any other contract between Contractor and the MDOC. The rights of the MDOC are in addition and without prejudice to any other right the MDOC may have to claim the amount of any loss or damage suffered by the MDOC on account of the acts or omissions of Contractor.

- 28. Renewal of Contract.** The contract may be renewed at the discretion of the MDOC for a period of 2 successive one-year periods under the same prices, terms, and conditions as in the original contract. The total number of renewal years permitted shall not exceed two (2).
- 29. Requirements Contract.** During the period of the contract, Contractor shall provide all services described in the contract. Contractor understands and agrees that this is a requirement contract and that the MDOC shall have no obligation to Contractor if no services are required. Any quantities that are included in the scope of work reflect the current expectations of the MDOC for the period of the contract. The amount is only an estimate and Contractor understands and agrees that the MDOC is under no obligation to Contractor to utilize any amount of the services as a result of having provided this estimate or of having any typical or measurable requirement in the past. Contractor further understands and agrees that the MDOC may require services in an amount less than or in excess of the estimated annual contract amount and that the quantity actually used, whether in excess of the estimate or less than the estimate, shall not give rise to any claim for compensation other than the total of the unit prices in the contract for the quantity actually used.
- 30. Right to Audit.** Contractor shall maintain such financial records and other records as may be prescribed by the MDOC or by applicable federal and state laws and regulations. Contractor shall retain these records for a period of three years after final payment, or until they are audited by the MDOC, whichever event occurs first. These records shall be made available during the term of the contract and the subsequent three-year period for examination, transcription, and audit by the MDOC, the Mississippi State Auditor's Office, and/or other entity of the state.
- 31. Severability.** If any part of this agreement is declared to be invalid or unenforceable, such invalidity or unenforceability shall not affect any other provision of the agreement that can be given effect without the invalid or unenforceable provision, and to this end the provisions hereof are severable. In such event, the parties shall amend the agreement as necessary to reflect the original intent of the parties and to bring any invalid or unenforceable provisions in compliance with applicable law.
- 32. State Property.** Contractor will be responsible for the proper custody and care of any state-owned property furnished for Contractor's use in connection with the performance of this agreement. Contractor will reimburse the state for any loss or damage, normal wear and tear excepted.
- 33. Third Party Action Notification.** Contractor shall give the customer prompt notice in writing of any action or suit filed, and prompt notice of any claim made against Contractor by any entity that may result in litigation related in any way to this agreement.

APPENDICES

APPENDIX A – Additional Menu Details

1. Tomato products, baked beans, applesauce, and fruits may be canned.
2. Dried products include dehydrated potatoes, beans, peas, and pasta.
3. All other vegetables will be delivered fresh or frozen.
4. With the exception of some Holiday Meals, there will be no pork products allowed.
5. Menu will be Heart Healthy and Consistent Carbohydrate compliant.
6. Menu will average 2,900 calories per day and at least 80 grams of protein.
7. Chicken leg quarters will be served at least one day per week.
8. Bakery mixes will be “add water only”.
9. Fresh eggs will be served at least twice per week. Frozen egg patties are allowed but will not take the place of fresh eggs requirement.
10. Ground beef will be no less than 73/27. Ground chicken and Ground turkey can be interchanged, but no mechanically separated products will be allowed.
11. Premade meat patties may be utilized in some cases but must be approved by MDOC Foodservice Director in advance. Meatloaf, Salisbury Steak, Chili are made from raw ingredients.
12. MDOC facilities can prepare large quantity meals from raw ingredients.
13. Any changes to menu must be approved by MDOC Foodservice Director or designee.
14. Successful bidder must provide MDOC with a Mississippi Registered Dietitian for consultations and guidance on an as needed basis regarding medical diets, religious diets, and changes in menus and ingredients etc. while keeping MDOC in compliance with ACA and Mississippi Health Department regulations.
15. MDOC will require daily pull sheets, weekly inventory guides, weekly grocery lists and weekly recipe cards for each property each week. MDOC will adhere to the recipes in preparing the meals and the pull sheets/order guides will reflect all ingredients needed at the specific property’s quantities.
